The Bidder shall provide and furnish all the materials, machinery, implements, appliances and tools, and perform the work and required labor to construct and complete State Highway Contract No. **D7POC405** in **Alamance County**, for the unit or lump sum prices, as the case may be, bid by the Bidder in his bid and according to the proposal, plans, and specifications prepared by said Department, which proposal, plans, and specifications show the details covering this project, and hereby become a part of this contract.

The published volume entitled *North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures, January 2018* with all amendments and supplements thereto, is by reference incorporated into and made a part of this contract; that, except as herein modified, all the construction and work included in this contract is to be done in accordance with the specifications contained in said volume, and amendments and supplements thereto, under the direction of the Engineer.

If the proposal is accepted and the award is made, the contract is valid only when signed either by the Contract Officer or such other person as may be designated by the Secretary to sign for the Department of Transportation. The conditions and provisions herein cannot be changed except over the signature of the said Contract Officer or Division Engineer.

The quantities shown in the itemized proposal for the project are considered to be approximate only and are given as the basis for comparison of bids. The Department of Transportation may increase or decrease the quantity of any item or portion of the work as may be deemed necessary or expedient.

An increase or decrease in the quantity of an item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

**All bids shall be prepared and submitted in accordance with the following requirements. Failure to comply with any requirement may cause the bid to be considered irregular and may be grounds for rejection of the bid.**

**TRADITIONAL PAPER BIDS:**

1. Small Business Enterprise bidders shall submit a SBE Application for Certification Form within the NC Online Certification System on the Department's website and have been approved by the Office of Civil Rights prior to bidding. The SBE shall submit this form for approval at a minimum of one week prior to bidding.
2. Download the entire proposal from the Connect NCDOT website and return the entire proposal with your bid.
3. If the Interested Parties List provision SP01 G02 is part of the proposal prior to submitting a bid on a project, the bidder shall sign up on the *Interested Parties List* in conformance with Interested Parties List provision SP01 G02.
4. All entries on the itemized proposal sheet (bid form) shall be written in ink or typed.
5. The Bidder shall submit a unit price for every item on the itemized proposal sheet. The unit prices for the various contract items shall be written in figures. Unit prices shall be rounded off by the Bidder to contain no more than FOUR decimal places.
6. An amount bid shall be entered on the itemized proposal sheet for every item. The amount bid for each item shall be determined by multiplying each unit bid by the quantity for that item, and shall be written in figures in the "Amount" column of the form.
7. The total amount bid shall be written in figures in the proper place on the bid form. The total amount bid shall be determined by adding the amounts bid for each item.
8. Changes to any entry shall be made by marking through the entry in ink and making the correct entry adjacent thereto in ink. A representative of the Bidder shall initial the change in ink. Do not use correction fluid, correction tape or similar product to make corrections.

**PROJECT SPECIAL PROVISIONS-GENERAL****GENERAL**

This contract is for **Tree Services** as needed along state-maintained roads in Alamance County. The Contractor shall furnish all material, services, labor, traffic control and equipment necessary for the required work. Sufficient experienced personnel shall be provided. **Personnel shall be legitimate employees of the Contractor. Because of the expertise required for this work, day laborers are not allowed.**

All work and materials shall be in accordance with the provisions of this contract, the Project Special Provisions, the *North Carolina Department of Transportation Standard Specifications for Roads and Structures*, the *North Carolina Department of Transportation Roadway Standards Drawings*, and the current edition of the *Manual of Uniform Traffic Control Devices (MUTCD)*.

The Contractor shall keep himself fully informed of all Federal, State and local laws, ordinances, and regulations, and shall comply with the provisions of Section 107 of the *Standard Specifications*.

The Contractor may work Monday through Friday during daylight hours (sun up to sun down) and other times as directed by the Engineer. Weekend and Holiday work will not be permitted unless otherwise approved by the Engineer. Work shall only be performed when weather and visibility conditions allow safe operations.

When the Engineer determines that the Contractor's operations may cause significant traffic delays on a given roadway, he may restrict working hours to **9:00 AM to 4:00 PM**. Unless otherwise directed by the Engineer, lane closures on all multilane facilities shall be restricted to **9:00 A.M. to 4:00 P. M.**

If the Contractor, in his opinion, determines that an alteration to the set working hours may be necessary or desirable, he shall notify the Engineer in writing prior to performing such work. The Engineer will investigate and notify the Contractor of any special conditions. No contract

adjustments or additional compensation will be allowed for work hour alterations requested by the Contractor.

**Liquidated Damages of Six Hundred Dollars (\$600.00) per hour or portion thereof will be charged for any work performed during restricted hours.**

### **BASIS OF AWARD**

Quantities for this work are unknown but will be determined on an as needed basis. Determination of the apparent low bidder will be made by extending the unit prices quoted on the Bid Proposal Form.

**Upon notification by the Engineer, the Contractor shall begin work within seven (7) calendar days. Failure to begin work within seven (7) will result in liquidated damages of Six Hundred Dollars (\$600.00) per calendar day. Liquidated damages will begin on the 8<sup>th</sup> consecutive calendar day after notification and will continue until the Contractor starts the requested work.**

The Contractor will be required to prosecute the work of each notification in a continuous and uninterrupted manner from the time he begins the work until completion and final acceptance of the project. The Contractor will not be permitted to suspend his operations except for reasons beyond his control or except where the Engineer has authorized a suspension of the Contractor's operations in writing.

In the event that the Contractor's operations are suspended in violation of the above provisions, the sum of **\$600.00** will be charged the Contractor for each and every calendar day that such suspension takes place. The said amount is hereby agreed upon as liquidated damages due to extra engineering and maintenance costs and due to increased public hazard resulting from a suspension of the work. **Liquidated damages chargeable due to suspension of the work will be additional to any liquidated damages that are chargeable due to failure to begin the work on time.**

This includes but is not limited to US 14 CFR Part 107 *Small UAS Rule*, NC GS 15A-300.2 *Regulation of launch and recovery sites*, NC GS 63-95 *Training required for the operation of unmanned aircraft systems*, NC GS 63-96 *Permit required for commercial operation of unmanned aircraft system*, and NCDOT UAS Policy. The required operator certifications include possessing a current Federal Aviation Administration (FAA) Remote Pilot Certificate, a NC UAS Operator Permit as well as operating a UAS registered with the FAA.

Prior to beginning operations, the Contractor shall complete the NCDOT UAS – Flight Operation Approval Form and submit it to the Engineer for approval. All UAS operations shall be approved by the Engineer prior to beginning the operations.

All contractors or subcontractors operating UAS shall have UAS specific general liability insurance to cover all operations under this contract.

The use of UAS is at the Contractor's discretion. No measurement or payment will be made for the use of UAS. In the event that the Department directs the Contractor to utilize UAS, payment will be in accordance with Article 104-7 Extra Work.

**EQUIPMENT IDLING GUIDELINES:**

(1-19-21)

Exercise reduced fuel consumption and reduced equipment emissions during the construction of all work associated with this contract. Employees engaged in the construction of this project should turn off vehicles when stopped for more than thirty (30) minutes and off-highway equipment should idle no longer than fifteen (15) consecutive minutes.

These guidelines for turning off vehicles and equipment when idling do not apply to:

1. Idling when queuing.
2. Idling to verify the vehicle is in safe operating condition.
3. Idling for testing, servicing, repairing or diagnostic purposes.
4. Idling necessary to accomplish work for which the vehicle was designed (such as operating a crane, mixing concrete, etc.).
5. Idling required to bring the machine system to operating temperature.
6. Emergency vehicles, utility company, construction, and maintenance vehicles where the engines must run to perform needed work.
7. Idling to ensure safe operation of the vehicle.
8. Idling when the propulsion engine is providing auxiliary power for other than heating or air conditioning. (such as hydraulic systems for pavers)
9. When specific traffic, safety, or emergency situations arise.
10. If the ambient temperature is less than 32 degrees Fahrenheit. Limited idling to provide for the safety of vehicle occupants (e.g. to run the heater).
11. If the ambient temperature is greater than 90 degrees Fahrenheit. Limited idling to provide for the safety of vehicle occupants of off-highway equipment (e.g. to run the air conditioning) no more than 30 minutes.
12. Diesel powered vehicles may idle for up to 30 minutes to minimize restart problems.

Any vehicle, truck, or equipment in which the primary source of fuel is natural gas or electricity is exempt from the idling limitations set forth in this special provision.

**Page 1-29, Subarticle 103-4(C), Award Limits**, line 4-8, delete and replace the first sentence in the first paragraph with the following:

A bidder who desires to bid on more than one project on which bids are to be opened in the same letting and who desires to avoid receiving an award of more projects than he is equipped to handle, may bid on any number of projects but may limit the total amount of work awarded to him on



selected projects by completing the form Award Limits on Multiple Projects for each project subject to the award limit.

The Contractor shall submit a bid for one year. At the option of the Department, this contract may be extended for **2 (two)** additional periods of one year each (**maximum (3) three years total**). Each year shall have a limit of **One Million Dollars (\$1,000,000.00)**.

The compensation payable to the contractor shall be fixed for the first twelve months of this contract. However, upon an application of renewal of the contract, or thirty days prior to the end of each contract period, the renewal contract may be adjusted to reflect the adjustment in the Consumer Price Index for the previous twelve-month period as published by the US Bureau of Labor and Statistics at <http://www.bls.gov/cpi> to be applied to new work order assignments. The Consumer Price Index for All Urban Consumers (CPI-U), US City Average, All Items, 1982-84=100, not seasonally adjusted will be used. If the amount of the requested adjustment is more than ten percent, the Department of Transportation reserves the right to cancel this contract.

#### **CONTRACTOR'S OPERATIONS PLAN**

(9-25-12)

Div . 7

The Contractor shall use sound and established arboricultural principles for pruning and removal trees of various size, number and condition as identified by the Engineer. The Contractor shall utilize power and hand tools, aerial bucket trucks, skilled climbers, powered self-propelled equipment or combination thereof in order to complete a specified notification.

All trimmings, laps, brush, debris, or other vegetative material produced by the operations shall be chipped and disposed of by the Contractor as directed by the Engineer. Wood chips shall become the property of the contractor. Upon approval by the Engineer chips may be spread within the highway right of way so as not to interfere with drainage, sight distances, or turf growth. No burning or burying will be allowed on highway's rights of way. All other trash shall be disposed at an approved public landfill at the Contractor's expense before payment is made.

The Contractor is to perform work approved by the Engineer only. Work performed on adjacent property is prohibited.

Any damage to adjacent vegetation, shoulders, medians, lawns, fences, signs, paved areas, or other facilities shall be repaired and/or replaced to the satisfaction of the Engineer and at the Contractor's expense.

Any work performed in an unsatisfactory manner could be basis for cancellation of the contract.

- 1 Loading Equipment with Operator
- \* 2 Chainsaws with Operator
- 4 Flagmen Laborers

**\* The Contractor shall provide a minimum of 1 chainsaw operator properly trained and equipped to perform tree climbing per crew.**

If the Contractor, in his opinion, determines that an alteration to crew size or make up may be necessary or desirable, he shall notify the Engineer prior to performing such work. The Engineer will investigate the request and notify the Contractor of his determination. The contractor shall not modify the crew size or make up without authorization of the Engineer. No contract adjustments or additional compensation will be allowed for crew alterations.

All personnel shall adhere to all OSHA guidelines. **Personnel shall wear vision and hearing protection as required. All personnel shall wear an approved safety vest, work boots, shirts with sleeves and long pants. Safety vests shall meet or exceed ANSI Class II standards. Workers shall use all required personal protective equipment.** Workers or operators shall not wear any loose clothing or jewelry. If any clothing, vest, or jewelry can become entangled in the moving parts of the chipper it shall be removed prior to the chipping operation.

Workers shall possess the appropriate licenses and skills for the equipment used and tasks assigned.

**Equipment**

The contractor may be required to supplement power tools with hand tools when needed to successfully complete the required tree service. Hand tools will be considered incidental in nature and no additional compensation will be made.

Equipment shall be in good working order and all original equipment safety devices shall be in place. At any time the engineer may reject any equipment that is not operating in a satisfactory manner.

All equipment not listed shall be considered incidental to the various other line items included in the contract and no additional compensation shall be paid.

The following equipment will be required on an as needed basis:

**Bucket Truck with Operator**

Bucket Trucks shall have minimum operating reach of 50'. Each truck shall be properly licensed and shall meet all motor vehicle/motor carrier standards as required by law. Vehicle components shall be constructed and maintained in a manner to ensure structural integrity. Vehicles found to be structurally deficient will be removed from the project until repairs are made. Trucks shall be equipped with all necessary safety devices including an operable back up alarm. Vehicles found to be without a functional alarm will be removed from the project until repairs are made.

**Chipper with Operator**

Chippers shall be rated to accommodate a minimum trunk diameter of 18". All original equipment manufacturer (OEM) safety devices and guards shall be in place and functional. Operators shall be fully trained and qualified to operate the machine. Chippers found to be in unsafe condition shall be removed from the project until repairs are made.

**Tow/Haul Vehicle with Operator**

Chipper tow/haul vehicles shall be a truck of sufficient gross vehicle weight rating to safely tow the attached chipper. The vehicle shall be equipped with a dump body with minimum capacity of 6 cubic yards. The truck shall be constructed and maintained in a manner to ensure structural integrity. Vehicles found to be structurally deficient will be removed from the project until repairs are made. Trucks shall be equipped with all necessary safety devices including an operable back up alarm. Vehicles found to be without a functional alarm will be removed from the project until repairs are made.

**Loading Equipment with Operator**

Loading equipment shall be self-propelled equipped with rubber tires and shall have a minimum capacity of ¾ CY. The loading attachment shall be of a "4-in-1" or grapple design capable of opening to grasp logs and debris. The equipment shall be equipped with operable amber warning lights and backup alarm. Equipment found to be without a functioning back up alarm shall be removed from the project until repairs are made. The contractor, at his option, may provide either a rubber-tired loader or rubber-tired backhoe, or boom truck for use in this project.

**Chainsaw with Operator**

Chainsaw operators shall be skilled in the operation of the chainsaw and must follow OSHA guidelines. Operators shall wear vision and hearing protection, chaps and clothing to provide sufficient protection from flying wood chips etc.

Climbers shall be properly trained and shall utilize all necessary rigging, lanyards and other required safety equipment for climbing activities in accordance with all applicable OSHA guidelines

Chainsaws shall be commercial grade, gasoline powered units with a minimum bar length of 18". All original equipment safety devices shall be in place. The Engineer may reject any equipment that is not operating in a satisfactory manner.

### **Laborer**

Laborers skilled in and knowledgeable in tree work shall be supplied.

### **Flagman**

**A Flaggers shall be qualified by a NCDOT approved training agency and shall be equipped in accordance with Section 1150 of the *Standard Specifications*.** Flaggers shall be furnished with proper safety devices and equipment, including, but not limited to, safety vests, orange hats, and stop/slow paddles. The Contractor shall provide a **Qualification Statement** that all flaggers to be used on the project have been properly trained and certified through a NCDOT approved training resource. Certification numbers of each flagger shall be included on the Qualification Statement.

Flagging operations shall be conducted in accordance with the *Manual on Uniform Traffic Control Devices (MUTCD)* and *NCDOT Roadway Standard Drawings*. Flagmen shall be skilled and knowledgeable in proper flagging techniques and shall wear fluorescent orange safety vests and hat. Flaggers shall not wear sunglasses and shall remain standing at all times during flagging operations. Flaggers shall be equipped with radios or other means of communication in order to facilitate safe traffic operation. Stop/Slow Paddles shall be in good condition.

### **Measurement and Basis of Payment**

Measurement and payment for the work shall be each hour or portion thereof that each requested piece of equipment and operator or employee is in productive operation as directed by the Engineer. Measurement shall be made for each pay item to the nearest ¼ hour. The Contractor shall not be paid for down time due to meals, equipment failure, unsatisfactory weather, or any other conditions.

**STUMP GRINDING**

Upon direction of the Engineer, the contractor shall grind tree stumps to an elevation of 6 inches below the existing ground surface. The contractor shall conduct his operations so as to minimize disturbance of the surrounding area. The contractor shall remove all debris generated by his operations and shall backfill all voids created by the grinding operation flush to the surrounding ground elevation.

**Measurement and basis of payment**

Measurement and payment for the work of stump grinding shall be for each inch of the trunk diameter or portion thereof of tree stumps satisfactorily ground and backfilled. Payment for these three additional hours shall be considered full compensation for all costs to mobilize and demobilize the equipment and labor provided under this contract. Mobilization shall include cessation of normal operations and preparing and transporting the equipment and personnel ready for the operation at the NCDOT County Maintenance Facility.

**No payment for Emergency Mobilization will be made for any personnel or equipment not made ready and available within (3) three hours of notification.**

**Liquidated Damages of Six Hundred Dollars (\$600.00) per hour will be charged the Contractor for each hour or portion thereof over three hours that full, successful mobilization has not occurred.**

**EROSION CONTROL:**

The Contractor shall exercise every reasonable precaution throughout the life of the project to prevent erosion and siltation. In the event that the Contractor's operations create erodible surfaces, the Contractor shall install appropriate erosion control devices as determined by the Engineer.

Erosion Control devices may include but shall not be limited to seeding and mulching, Silt Fence, Erosion Control Stone and Sediment Control Stone.

**No direct payment shall be made for erosion control items or installation, as they shall be considered incidental to other contract items.**

### **UTILITY CONFLICTS**

Special care shall be used when working around or near existing utilities, protecting them when necessary to provide uninterrupted service. In the event that any utility service is interrupted, the Contractor shall notify the utility owner immediately and shall cooperate with the owner, or his representative, in the restoration of service in the shortest time possible. Existing fire hydrants shall be kept accessible to fire departments at all times.

The Contractor shall adhere to all applicable regulations and follow accepted safety procedures when working in the vicinity of utilities in order to insure the safety of the construction personnel and the public.

### **BASIS OF PAYMENT:**

The quantities contained herein are estimated only and the quantity to be paid for shall be the actual quantities which were used on the project. All work items, other than those listed on the Bid Form contained in the Contract Proposal, necessary to complete this work will be considered incidental in nature and no further compensation will be made.

The Contractor will submit a request for payment on an interval approved by the Engineer. Compensation for all pay items shall be in accordance with the Standard Specifications. The amount of the payment will be based on the work accomplished and accepted on the last day of the approved pay period.

(ii) Cancelling, terminating, or suspending a contract, in whole or in part.

(f) Incorporation of Provisions

The contractor shall include the provisions of paragraphs (a) through (f) in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Acts, the Regulations and directives issued pursuant thereto. The contractor shall take action with respect to any subcontract or procurement as the Recipient or the FHWA may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the contractor becomes involved in, or

is threatened with litigation by a subcontractor, or supplier because of such direction, the contractor may request the Recipient to enter into any litigation to protect the interests of the Recipient. In addition, the contractor may request the United States to enter into the litigation to protect the interests of the United States.

**(2) Title VI Nondiscrimination Program (23 CFR 200.5(p))**

The North Carolina Department of Transportation (NCDOT) has assured the USDOT that, as a condition to receiving federal financial assistance, NCDOT will comply with Title VI of the Civil Rights Act of 1964 and all requirements imposed by Title 49 CFR part 21 and related nondiscrimination authorities to ensure that no person shall, on the ground of race, color, national origin, limited English proficiency, sex, age, or disability (including religion/creed or income-level, where applicable), be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any programs, activities, or services conducted or funded by NCDOT. 3. Required Solicitation Language. The Contractor shall include the following notification in all solicitations for bids and requests for work or material, regardless of funding source:  
"The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award. In accordance with other related nondiscrimination authorities, bidders and contractors will also not be discriminated against on the grounds of sex, age, disability, low-income level, creed/religion, or limited English proficiency in consideration for an award."
4. Physically incorporate the FHWA-1273, in its entirety, into all subcontracts and subsequent lower tier subcontracts on Federal-aid highway construction contracts only.
5. Provide language assistance services (i.e., written translation and oral interpretation), free of charge, to LEP employees and applicants. Contact NCDOT OCR for further assistance, if needed.
6. For assistance with these Title VI requirements, contact the NCDOT Title VI Nondiscrimination Program at 1-800-522-0453.

- (b) Subrecipients (e.g. cities, counties, LGAs, planning organizations) may be required to prepare and submit a Title VI Plan to NCDOT, including Title VI Assurances and/or agreements. Subrecipients must also ensure compliance by their contractors and subrecipients with Title VI. (23 CFR 200.9(b)(7))
- (c) If reviewed or investigated by NCDOT, the contractor or subrecipient agrees to take affirmative action to correct any deficiencies found within a reasonable time period, not to exceed 90 calendar days, unless additional time is granted by NCDOT. (23 CFR 200.9(b)(15))
- (d) The Contractor is responsible for notifying subcontractors of NCDOT's External Discrimination Complaints Process.
  - 1. Applicability  
Title VI and related laws protect participants and beneficiaries (e.g., members of the public and contractors) from discrimination by NCDOT employees, subrecipients and contractors, regardless of funding source.
  - 2. Eligibility  
Any person—or class of persons—who believes he/she has been subjected to discrimination based on race, color, national origin, Limited English Proficiency (LEP), sex, age, or disability (and religion in the context of employment, aviation, or transit) may file a written complaint. Allegations received by telephone will be reduced to writing and provided to the complainant for confirmation or revision before processing. Complaints will be accepted in other languages, including Braille.

6. Complaint Basis

Allegations must be based on issues involving race, color, national origin (LEP), sex, age, disability, or religion (in the context of employment, aviation or transit). “Basis” refers to the complainant’s membership in a protected group category.

**(HABENDUM CLAUSE)**

TO HAVE AND TO HOLD said lands and interests therein unto the North Carolina Department of Transportation (NCDOT) and its successors forever, subject, however, to the covenants, conditions, restrictions and reservations herein contained as follows, which will remain in effect for the period during which the real property or structures are used for a purpose for which Federal financial assistance is extended or for another purpose involving the provision of similar services or benefits and will be binding on the NCDOT, its successors and assigns.

The NCDOT, in consideration of the conveyance of said lands and interests in lands, does hereby covenant and agree as a covenant running with the land for itself, its successors and assigns, that (1) no person will on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination with regard to any facility located wholly or in part on, over, or under such lands hereby conveyed [,] [and]\* (2) that the NCDOT will use the lands and interests in lands and interests in lands so conveyed, in compliance with all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the U.S. Department of Transportation, Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations and Acts may be amended [, and (3) that in the event of breach of any of the above-mentioned nondiscrimination conditions, the Department will have a right to

enter or re-enter said lands and facilities on said land, and that above described land and facilities will thereon revert to and vest in and become the absolute property of the U.S. Department of Transportation and its assigns as such interest existed prior to this instruction].\*

(\*Reverter clause and related language to be used only when it is determined that such a clause is necessary in order to make clear the purpose of Title VI.)

(b) Clauses for Transfer of Real Property Acquired or Improved Under the Activity, Facility, or Program (1050.2A, Appendix C)

The following clauses will be included in deeds, licenses, leases, permits, or similar instruments entered into by the North Carolina Department of Transportation (NCDOT) pursuant to the provisions of Assurance 7(a):

1. The (grantee, lessee, permittee, etc. as appropriate) for himself/herself, his/her heirs, personal representatives, successors in interest, and assigns, as a part of the consideration hereof, does hereby covenant and agree [in the case of deeds and leases add "as a covenant running with the land"] that:
  - (i.) In the event facilities are constructed, maintained, or otherwise operated on the property described in this (deed, license, lease, permit, etc.) for a purpose for which a U.S. Department of Transportation activity, facility, or program is extended or for another purpose involving the provision of similar services or benefits, the (grantee, licensee, lessee, permittee, etc.) will maintain and operate such facilities and services in compliance with all requirements imposed by the Acts and Regulations (as may be amended) such that no person on the grounds of race, color, or national origin, will be excluded from participation in, denied the benefits of, or be otherwise subjected to discrimination in the use of said facilities.
2. With respect to licenses, leases, permits, etc., in the event of breach of any of the above Nondiscrimination covenants, the NCDOT will have the right to terminate the (lease, license, permit, etc.) and to enter, re-enter, and repossess said lands and facilities thereon, and hold the same as if the (lease, license, permit, etc.) had never been made or issued. \*
3. With respect to a deed, in the event of breach of any of the above Nondiscrimination covenants, the NCDOT will have the right to enter or re-enter the lands and facilities thereon, and the above described lands and facilities will there upon revert to and vest in and become the absolute property of the NCDOT and its assigns. \*

The (grantee, licensee, permittee, etc., as appropriate) for himself/herself, his/her heirs, personal representatives, successors in interest, and assigns, as a part of the consideration hereof, does hereby covenant and agree (in the case of deeds and leases add, "as a covenant running with the land") that (1) no person on the ground of race, color, or national origin, will be excluded from participation in, denied the benefits of, or be otherwise subjected to discrimination in the use of said facilities, (2) that in the construction of any improvements on, over, or under such land, and the furnishing of services thereon, no person on the ground of race, color, or national origin, will be excluded from participation in, denied the benefits of, or otherwise be subjected to discrimination, (3) that the (grantee, licensee, lessee, permittee, etc.) will use the premises in compliance with all other requirements imposed by or pursuant to the Acts and Regulations, as amended, set forth in this Assurance.

### **ON-THE-JOB TRAINING**

(10-16-07) (Rev. 4-21-15)

Z-10

#### **Description**

The North Carolina Department of Transportation will administer a custom version of the Federal On-the-Job Training (OJT) Program, commonly referred to as the Alternate OJT Program. All contractors (existing and newcomers) will be automatically placed in the Alternate Program. Standard OJT requirements typically associated with individual projects will no longer be applied at the project level. Instead, these requirements will be applicable on an annual basis for each contractor administered by the OJT Program Manager.

On the Job Training shall meet the requirements of 23 CFR 230.107 (b), 23 USC – Section 140, this provision and the On-the-Job Training Program Manual.

The Alternate OJT Program will allow a contractor to train employees on Federal, State and privately funded projects located in North Carolina. However, priority shall be given to training employees on NCDOT Federal-Aid funded projects.

#### **Minorities and Women**

Developing, training and upgrading of minorities and women toward journeyman level status is a primary objective of this special training provision. Accordingly, the Contractor shall make every

effort to enroll minority and women as trainees to the extent that such persons are available within a reasonable area of recruitment. This training commitment is not intended, and shall not be used, to discriminate against any applicant for training, whether a member of a minority group or not.

### **Assigning Training Goals**

The Department, through the OJT Program Manager, will assign training goals for a calendar year based on the contractors' past three years' activity and the contractors' anticipated upcoming year's activity with the Department. At the beginning of each year, all contractors eligible will be contacted by the Department to determine the number of trainees that will be assigned for the upcoming calendar year. At that time the Contractor shall enter into an agreement with the Department to provide a self-imposed on-the-job training program for the calendar year. This agreement will include a specific number of annual training goals agreed to by both parties. The number of training assignments may range from 1 to 15 per contractor per calendar year. The Contractor shall sign an agreement to fulfill their annual goal for the year.\

### **Training Classifications**

The Contractor shall provide on-the-job training aimed at developing full journeyman level workers in the construction craft/operator positions. Preference shall be given to providing training in the following skilled work classifications:

Equipment Operators	Office Engineers
Truck Drivers	Estimators
Carpenters	Iron / Reinforcing Steel Workers
Concrete Finishers	Mechanics
Pipe Layers	Welders

The Department has established common training classifications and their respective training requirements that may be used by the contractors. However, the classifications established are not all-inclusive. Where the training is oriented toward construction applications, training will be allowed in lower-level management positions such as office engineers and estimators. Contractors shall submit new classifications for specific job functions that their employees are performing. The Department will review and recommend for acceptance to FHWA the new classifications proposed by contractors, if applicable. New classifications shall meet the following requirements:

Proposed training classifications are reasonable and realistic based on the job skill classification needs, and

The number of training hours specified in the training classification is consistent with common practices and provides enough time for the trainee to obtain journeyman level status.

The Contractor may allow trainees to be trained by a subcontractor provided that the Contractor retains primary responsibility for meeting the training and this provision is made applicable to the

subcontract. However, only the Contractor will receive credit towards the annual goal for the trainee.

Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training. The number of trainees shall be distributed among the work classifications on the basis of the contractor's needs and the availability of journeymen in the various classifications within a reasonable area of recruitment.

No employee shall be employed as a trainee in any classification in which they have successfully completed a training course leading to journeyman level status or in which they have been employed as a journeyman.

### **Records and Reports**

The Contractor shall maintain enrollment, monthly and completion reports documenting company compliance under these contract documents. These documents and any other information as requested shall be submitted to the OJT Program Manager.

Upon completion and graduation of the program, the Contractor shall provide each trainee with a certification Certificate showing the type and length of training satisfactorily completed.

### **Trainee Interviews**

All trainees enrolled in the program will receive an initial and Trainee/Post graduate interview conducted by the OJT program staff.

### **Trainee Wages**

Contractors shall compensate trainees on a graduating pay scale based upon a percentage of the prevailing minimum journeyman wages (Davis-Bacon Act). Minimum pay shall be as follows:

60 percent	of the journeyman wage for the first half of the training period
75 percent	of the journeyman wage for the third quarter of the training period
90 percent	of the journeyman wage for the last quarter of the training period

In no instance shall a trainee be paid less than the local minimum wage. The Contractor shall adhere to the minimum hourly wage rate that will satisfy both the NC Department of Labor (NCDOL) and the Department.

### **Achieving or Failing to Meet Training Goals**

The Contractor will be credited for each trainee employed by him on the contract work who is currently enrolled or becomes enrolled in an approved program and who receives training for at least 50 percent of the specific program requirement. Trainees will be allowed to be transferred between projects if required by the Contractor's scheduled workload to meet training goals.

If a contractor fails to attain their training assignments for the calendar year, they may be taken off the NCDOT's Bidders List.

**Measurement and Payment**

No compensation will be made for providing required training in accordance with these contract documents.

## **TEMPORARY TRAFFIC CONTROL**

(02/19/2021)

### **GENERAL REQUIREMENTS**

The Contractor shall maintain traffic on all roads during construction and shall furnish, install, relocate, maintain, and remove traffic control devices as shown in the *Roadway Standard Drawings* or as directed by the Engineer.

Maintain traffic in accordance with Divisions 10, 11 and 12 of the *2018 Standard Specifications* and the following provisions:

Install Work Zone Advance Warning Signs in accordance with Standard Drawing No. 1101.01 of the *2018 Roadway Standard Drawings* prior to beginning any other work.

Remove lane closure devices from the lane when work is not being performed behind the lane closure or when a lane closure is no longer needed or as directed by the Engineer.

When Personnel and/or equipment are working within 15 ft. of an open travel lane, close the nearest open shoulder using Roadway Standard Drawing No. 1101.04 unless the work area is protected by barrier or guardrail or a lane closure is installed.

When personnel and/or equipment are working on the shoulder adjacent to an undivided facility and within 5 ft. of an open travel lane, close the nearest open travel lane using Roadway Standard Drawing No. 1101.02 of the *2018 Roadway Standard Drawings unless the work area is protected by barrier or guardrail.*

When personnel and/or equipment are working on the shoulder adjacent to a divided facility and within 10 ft. of an open travel lane, close the nearest open travel lane using Roadway Standard Drawing No. 1101.02 of the *2018 Roadway Standard Drawings, unless the work area is protected by barrier or guardrail.*

When personnel and/or equipment are working within a lane of travel of an undivided or divided facility, close the lane using Roadway Standard Drawing No. 1101.02 of the *2018 Roadway Standard Drawings* or as directed by the Engineer. Conduct the work so that all personnel and/or equipment remain within the closed travel lane. Perform work only when weather and visibility conditions allow safe operations as directed by the Engineer.

Do not work simultaneously within 15 ft. on both sides of an open travelway, ramp, or loop within the same location, unless protected with guardrail or barrier.

Notify the Engineer (30) calendar days prior to any traffic pattern alteration.

Ensure all necessary signing is in place prior to altering any traffic pattern.

## TC-3

Division 7

Law Enforcement shall be used to maintain traffic through the work area and/or intersections as directed by the Engineer.

Contractor shall maintain sidewalk access at all times. Contractor shall be responsible to provide temporary sidewalks (concrete, asphalt, or other suitable material as approved by the engineer) at all locations where the open pedestrian travelway has been closed/removed for construction operations. ADA compliant pedestrian barricades/channelizing devices shall be used to close sidewalks and redirect pedestrians along the temporary sidewalk, as directed by the Engineer. Mount appropriate sidewalk closure and pedestrian detour signs to these barricades/channelizing devices to inform pedestrians of the closure and pedestrian detour. See Special Provision (ADA Compliant Pedestrian Traffic Control Devices).

When lane closures are not in effect, space channelizing devices in work areas no greater in feet than twice the posted speed limit (MHP), except 10 ft. on-center in radii, and 3 ft. off the edge of an open travelway. Refer to *2018 Standard Specifications* Sections 1130 (Drums), 1135 (Cones), and 1180 (Skinny Drums) for additional requirements.

Place additional sets of three channelizing devices (Drums, Cones, or Skinny Drums) perpendicular to the edge of travelway on 100 to 500 ft. centers (as directed by the Engineer) when unopened lanes are closed to traffic.

### **Time Restrictions for Lane Closure and Road Closure Activities**

All lane closure and road closure activities shall be performed in compliance with the Day and Time restrictions listed and defined in this Contract.

Any activities performed outside of these requirements will be subject to the Liquidated Damages unless approved by the Engineer prior to beginning the activity.

The Contractor may place/pre-stage all required signs and traffic control devices necessary for lane closures prior to the closure time as approved by the Engineer. The travel lane(s) are to be closed at the prescribed times defined in this Contract.

For removal, the lane(s) must be reopened in compliance with the times defined in this Contract. It is acceptable to remove the signs and traffic control devices from the shoulder/staging area after the lane(s) are reopened to traffic.

### **TEMPORARY TRAFFIC CONTROL (TTC)**

Refer to Standard Drawing No. 1101.01, 1101.02, 1101.04, 1101.11, 1110.01, 1110.02, 1115.01, 1130.01, 1135.01, 1145.01, 1150.01, 1165.01, and 1180.01 of the *2018 Roadway Standard Drawings* when closing a lane of travel in the work zone.

Drums are recommended for all lane closure operations occurring at night. If the contractor elects to use skinny drums at night, the contractor shall space skinny drums no greater than 20 ft. apart in the tangent sections of the lane closure. Skinny drums shall not be used for tapers.

When covering work zone signs, use an opaque material that prevents reading of the sign at night by a driver using high beam headlights. Use material which does not damage the sign sheeting. Tape shall not be affixed to the sign sheeting at any time.

## **TRAFFIC OPERATIONS**

### **1. Project Requirements:**

The Contractor shall comply with the following requirements. Non-compliance will result in a suspension of all work operations:

- A. Submit a written construction sequence for traffic control and construction lighting to the Engineer prior to the first pre-construction meeting. The sequence must be approved before beginning work or closing a lane of traffic. The Contractor and Engineer will coordinate with the Regional Work Zone Traffic Control Engineer for additional traffic control guidance, as necessary.
- B. Obtain written approval of the Engineer before working in more than one location or setting up additional lane closures.
- C. The Contractor on this and any adjacent projects, or subcontractors working within this project shall coordinate lane closure location, type, and direction with the Engineer to best maintain lane continuity through the limits of this and adjacent projects.
- D. Operate equipment and conduct operations in the same direction as the flow of traffic unless the operation is protected by barrier or guardrail or as directed by the Engineer. Maintain vehicular access in accordance with Section 1101-05 of the *2018 Standard Specifications*.
- E. Provide appropriate construction lighting in accordance with Section 1413 of the *2018 Standard Specifications*.

### **2. Work Zone Signing:**

#### **A. Description**

Install and maintain signing in accordance with the Divisions 10 and 11 of the *2018 Standard Specifications*.

#### **B. Installation**

All stationary Advance/General warning work zone signs require notification to existing Utility owners per Article 105-8 of the *2018 Standard Specifications* within 3 to 12 full working days prior to installation.

Install all Advance/General warning work zone signs before beginning work. If signs are installed more than three (3) calendar days prior to the beginning of work, cover the signs

until the work begins. Install each work zone Advance/General warning sign separately and not on the same post or stand with any other sign except where an advisory speed plate or directional arrow is used.

All sign locations to be verified by the Engineer prior to installation.

If there is a period of construction inactivity longer than fourteen (14) calendar days, remove or cover advance/general warning work zone signs. Uncover advance/general warning work zone signs no more than three (3) calendar days before work resumes.

All other operations may be suspended upon failure to comply with the above requirements. Such suspended operations would not be resumed until the above requirements are fulfilled.

## **C. Sign Removal**

Once the Project is substantially completed, the Contractor shall remove the Stationary Work Zone Signs. Any remaining punch list items requiring traffic control are to be completed with portable work zone signing.

## **MEASUREMENT AND PAYMENT**

No separate payment will be made for *Traffic Control* as the work is considered incidental to the other contract items.

*Law Enforcement* will be measured and paid in accordance with Article 1190-3.
