- 4. Install Rip Rap at inlet and outlet of pipe.
- 5. Contractor shall use a silenced pump at night.
- 6. Erosion Control Quantities 300LF Silt Fence, 300SY Matting, 0.30AC Seeding and Mulching and 4 Wattles.
- 7. Replace Contract Proposal Cover Sheet with attached sheet.
- 8. Replace Proposal page 33 with the attached Proposal page 33.
