Please refer to Article 107-15 of the Standard Specifications. The certificate of insurance must be returned to this office by 12:00 Noon June 22, 2017.

In addition, please submit written documentation of bidder commitment to use DBE subcontractors with the required "Letter of Intent to Perform as Subcontractor" for each subcontractor. This information must be returned to this office by 12:00 Noon June 22, 2017.
