This is to advise that your bid submitted for the above referenced project in the amount of \$426,090.00 was the lowest responsible bid. The Department has accepted this bid and has awarded the contract to EASTERN STRUCTURES, LLC.

The Combined MBE/WBE Goal for this project is **9.0%**. Based on the information you included on the *Listing of MBE/WBE Subcontractors Form*, your firm submitted a Combined goal of **5.8%**. Therefore, your Bid Proposal indicates **inadequate MBE and/or WBE participation** to satisfy the advertised contract goal.

In lieu of submitting a Good Faith Effort package for review, your firm has made a request for the withdrawal of banked funds to meet the MBE/WBE participation goal shortfall. This request has been approved. Therefore, the withdrawn banked funds in the amount of \$13,630.60 will be used to meet the Contract Goal Requirements.

We are requesting that you furnish two (2) properly executed signature sheets and two (2) sets of 100% Payment and Performance Bonds covering this work. Section 103-7 of the Standard Specifications requires the Contractor to provide the required bonds within 14 days of notification. The forms are available at: https://connect.ncdot.gov/letting/Pages/Central-Letting-Forms.aspx.

Also, please furnish the required certificate of insurance on the standard ACORD form as soon as possible. The insurance shall be in the amount of five million dollars (\$5,000,000.00) and the State of North Carolina shall be named as an additional insured on the policy. Please refer to

Article 107-15 of the *Standard Specifications*. The certificate of insurance must be returned to this office by 12:00 Noon November 13, 2020

In addition, please submit written documentation of bidder commitment to use MBE/WBE subcontractors with the required "Letter of Intent to Perform as Subcontractor" for each subcontractor. This form is available at: https://connect.ncdot.gov/letting/LetCentral/Letter%20of%20Intent%20to%20Perform%20as%20a%20Subcontractor.pdf. This information must be returned to this office by 12:00 Noon November 13, 2020
