AWARD OF CONTRACT

The award of the contract, if it be awarded, will be made to the lowest responsible Bidder in accordance with Section 102 (excluding 102-2 and 102-10) of the current edition of the Standard Specifications for Roads and Structures. The lowest responsible bidder will be notified that his bid has been accepted and that he has been awarded the contract. NCDOT reserves the right to reject any or all bids.

PURCHASE ORDER CONTRACT PROJECT SPECIAL PROVISIONS

GENERAL

This contract is for repairing, and/or replacing woven wire fence and chain link fence and resetting various fence as needed in Hoke, Lee, Moore, Richmond, and Scotland Counties.

All work and materials shall be in accordance with the provisions of the General Guidelines of this contract, the Project Special Provisions, the North Carolina Department of Transportation *Standard Specifications for Roads and Structures*, the current edition of the North Carolina Department of Transportation *Roadway Standards Drawings*, and the current edition of the *Manual of Uniform Traffic Control Devices* (MUTCD).

Wherever reference is given to codes, or standard specifications, or other data published by regulating agencies or accepted organizations, including but not limited to N.C. State Building Codes. Federal Specifications, ASTM Specifications, N.C. Department of Transportation "Standard Specifications for Roads and Structures", and the like, it shall be understood that such reference is to the latest edition including addenda published prior to and after the date of the contract documents.

The Contractor shall keep himself fully informed of all Federal, State and local laws, ordinances, and regulations, and shall comply with the provisions of Section 107 of the *Standard Specifications*.

SMALL BUSINESS ENTERPRISE PROGRAM

This is a **Small Business Enterprise Program** project, and as such, will be restricted to businesses with a gross income of not more than \$1.5 million, excluding materials during the previous calendar year. The Department's normal bonding and Contractor license requirements will be waived. Since general liability insurance is required, a copy of a certificate of insurance must also be submitted. Proof of small business status will be the previous year's income tax return. A copy of this return does not have to be submitted with this bid proposal, but may be requested at a later date.

CONTRACT TIME AND LIQUIDATED DAMAGES:

(7-20-99) (Rev. 12-18-07) 108 SPI G04

1. Term of the Contract - The Contractor shall submit his bid for one year. At the option of the Department, this contract may be extended for two (2) additional periods of one (1) year each (maximum three (3) years total). No changes in the terms, conditions, etc. of this contract will be made when an extension to the contract is implemented, except that there will be a clause to allow up to a maximum 5% increase in the existing contract unit prices. The Engineer will notify the Contractor in writing 60 days prior to the contract expiration date if the contract may be extended. The Contractor must notify the Engineer within 15 days of receiving the extension offer of his/her acceptance or rejection. Failure on the part of the Contractor to reply will be received as a rejection of contract extension.

- 2. The date of availability for this project is UPON ISSUANCE OF PURCHASE **ORDER**. The Contractor will be notified in writing by the Engineer of job location and scope. Projects will be assigned on an as needed basis by the Engineer or his duly authorized representative. The Contractor will be required to pursue the work in a continuous and uninterrupted manner from the time he begins work until completion and acceptance of the work. Failure to begin work within 5 days of notification for each routine project or failure to pursue work in a continuous and uninterrupted manner may result in cancellation of the Contract. No work will be permitted and no purchase order will be issued until all prerequisite conditions and certifications have been satisfied.
- 3. The completion date for this contract is **NOVEMBER 30, 2018.** If the term of the contract is extended, the date of availability in succeeding years will be October 1st, and the completion date will be September 30th each year. No extensions to the completion date will be authorized except as allowed by Article 108-10 of the current edition of the Standard Specifications.
- 4. Liquidated damages for this contract are One Hundred Dollars (\$100.00) per calendar day for each calendar day when the Contractor fails to report to the project, which begins 14 days after initial notification, or does not complete project deadlines as required by the County Maintenance Engineer.

BASIS OF AWARD:

The Contractor is advised that this is an annual needs contract and that the quantities as shown on the bid form are estimates only. Actual quantities will be determined on an as needed basis. The quantities shown on the bid form will be used to establish unit prices for each line item and determination of low bid only. The Contractor shall submit a unit price for every item on the bid form. The Department reserves the right to increase or reduce quantities with no adjustment in unit prices.

Unit prices should reflect actual costs; in accordance with Article 102-14, unbalanced bids may be rejected.

Quotations will be evaluated based on the total bid of all items. There are no guarantees either stated or implied for the quantities as shown on the bid form. Payment to the successful low bidder will be based on actual quantities of work performed and accepted at the PER UNIT PRICE for each item as quoted.

The Department reserves the right to reject any or all bids.

PROSECUTION OF WORK

The provisions of Section 108 shall apply with the following additions:

Upon notification by the Engineer, the Contractor shall begin work within fourteen (14) calendar days. Notification shall be by phone call, email, or letter and any of these methods shall be considered sufficient.

OUTSOURCING OUTSIDE THE USA

(9-21-04) (5-16-06)

SP1 G150

All work on consultant contracts, services contracts, and construction contracts shall be performed in the United States of America. No work shall be outsourced outside of the United States of America.

Outsourcing for the purpose of this provision is defined as the practice of subcontracting labor, work, services, staffing, or personnel to entities located outside of the United States.

The North Carolina Secretary of Transportation shall approve exceptions to this provision in writing.

GIFTS FROM VENDORS AND CONTRACTORS:

(12-15-09)

SP1 G152

By Executive Order 24, issued by Governor Perdue, and *N.C. G.S.*§ 133-32, it is unlawful for any vendor or contractor (i.e. architect, bidder, contractor, construction manager, design professional, engineer, landlord, offeror, seller, subcontractor, supplier, or vendor), to make gifts or to give favors to any State employee of the Governor's Cabinet Agencies (i.e. Administration, Commerce, Correction, Crime Control and Public Safety, Cultural Resources, Environment and Natural Resources, Health and Human Services, Juvenile Justice and Delinquency Prevention, Revenue, Transportation, and the Office of the Governor). This prohibition covers those vendors and contractors who:

- (1) have a contract with a governmental agency; or
- (2) have performed under such a contract within the past year; or
- (3) anticipate bidding on such a contract in the future.

LIABILITY INSURANCE:

(5-20-14) SPI G160

Revise the 2012 Standard Specifications as follows:

Page 1-60, Article 107-15 LIABILITY INSURANCE, line 16, add the following as the second sentence of the third paragraph:

Prior to beginning services, all contractors shall provide proof of coverage issued by a workers' compensation insurance carrier, or a certificate of compliance issued by the Department of Insurance for self-insured subcontractors, irrespective of whether having regularly in service fewer than three employees.

MAINTENANCE OF PROJECT:

The Contractor shall maintain the project from the date construction begins until project is finally accepted in accordance with Section 104-10, Maintenance of Project, Section 104-11, Final Clean Up, and Section 105-16, Failure to Maintain the Project or Perform Erosion Control Work.

CONTACT PERSONS

The contact person for work site coordination in Scotland County will be Mr. Joseph Standridge, County Maintenance Engineer (910) 369-2645. In Hoke County will be Mr. Joseph Standridge, County Maintenance Engineer (910) 875-3952. In Randolph County will be Mr. Aaron Saunders, County Maintenance Engineer (336) 318-4050. In Montgomery County, will be Mr. James Garner, County Maintenance Engineer at (910) 576-3667. In Richmond County, will be Mr. Chad Brown, County Maintenance Engineer at (910) 997-9164. In Moore County, will be County Maintenance Engineer at (910) 947-2233. In Lee County, will be County Maintenance Engineer at (919) 775-3122. The office hours for all the County Maintenance offices are 7:00 AM to 3:30 PM Monday through Friday. The contact person, or his authorized representative will contact the contractor with the location of work, the amount and type of fence to be reset or worked on. The contact person will also supply information as to whether the existing fence can be satisfactorily reset or if the property owner will be furnishing new material.

PAYMENT AND RETAINAGE

The basis for payment for this contract will be the unit prices bid for the pay items for various types of fences. Prices and payment will be full compensation for all work covered including all miscellaneous hardware to complete the work. All work items necessary to complete the work other than listed on the "Bid Proposal Form" will be considered incidental in nature and no further compensation will be made. Any work performed in an unsatisfactory manner could be the basis for cancellation of the contract.

Quantities on the "Bid Proposal Form" are for bid evaluation only and do not reflect the purchase order limits. Purchase order quantities will be based on actual need. Section 104-5 of the latest

Standard Specifications apply. The Engineer reserves the right to make, at any time during the work, such changes in the quantities as necessary to satisfactorily complete the project.

The fence, after work is completed, shall be in a condition that is equal to or better than the condition of the fence prior to the work. If any of the fence components are unnecessarily damaged by the contractor, the damaged components shall be replaced by the contractor at no expense to the Department of Transportation.

AUTHORITY OF THE ENGINEER

In accordance with Section 105 of the latest *Standard Specifications for Roads and Structures* and the following provisions: the Engineer for this project shall be the Division Engineer, Division 8, Division of Highways, North Carolina Department of Transportation, acting directly or through his duly authorized representatives.

The Engineer will decide all questions which may arise as to the quality and acceptability of work performed and as to the rate of progress of the work; all questions which may arise as to the interpretation of the contract; and all questions as to the acceptable fulfillment of the contract on the part of the Contractor. His decision shall be final and he shall have executive authority to enforce and make effective such decisions and orders as the Contractor fails to carry out promptly.

SUBLETTING OF CONTRACT

In accordance with Section 108, the Contractor is reminded that he shall not sublet, sell, transfer, assign, or otherwise dispose of the contract or any portion thereof; or of his right, title, or interest therein; without written consent of the Engineer.

MATERIALS AND TESTING

The Engineer reserves the right to perform all sampling and testing in accordance with Section 106 of the *Standard Specifications* and the Department's "Materials and Test Manual." However the Engineer may reduce the frequency of sampling and testing where he deems it appropriate for the project under construction.

The Contractor shall furnish the applicable certifications and documentation for all materials as required by the *Standard Specifications*. Material which is not properly certified will not be accepted.

UTILITY CONFLICTS

It shall be the responsibility of the Contractor to contact all affected utility owners and determine the precise locations of all utilities prior to beginning construction. Utility owners shall be contacted a minimum of 48 hours prior to the commencement of operations. Special care shall be used in working around or near existing utilities, protecting them when necessary to provide uninterrupted service. In the event that any utility service is interrupted, the Contractor shall notify the utility owner immediately and shall cooperate with the owner, or his representative, in the restoration of service in the shortest time possible. Existing fire hydrants shall be kept accessible to fire departments at all times.



The Contractor shall adhere to all applicable regulations and follow accepted safety procedures when working in the vicinity of utilities in order to insure the safety of construction personnel and the public.

INSPECTION

All work shall be subject to inspection by the Engineer at any time. Routinely, the Engineer will make periodic inspections of the completed work. It will be the responsibility of the Contractor to keep the Engineer informed of his proposed work plan and to submit written reports of work accomplished on a frequency to be determined by the Engineer.

SUPERVISION BY CONTRACTOR

At all times during the life of the project the Contractor shall provide one permanent employee who shall have the authority and capability for overall responsibility of the project and who shall be personally available at the work site within 24 hours notice. Such employee shall be fully authorized to negotiate and execute all supplemental agreements and to execute the orders or directions of the Engineer.

At all times that work is actually being performed, the Contractor shall have present on the project one competent individual who is authorized to act in a supervisory capacity over all work on the project. The individual who has been so authorized shall be experienced in the type of work being performed and shall be fully capable of managing, directing, and coordinating the work; of reading and thoroughly understanding the contract; and receiving and carrying out directions from the Engineer or his authorized representatives. He shall be an employee of the Contractor unless otherwise approved by the Engineer.

The Contractor may, at his option, designate one employee to meet the requirements of both positions. However, whenever the designated employee is absent from the work site, an authorized individual qualified to act in a supervisory capacity on the project shall be present.

EXTENSION OF CONTRACT TIME

Failure on the part of the Contractor to furnish bonds or certifications or to satisfy preliminary requirements necessary to issue the purchase order will not constitute grounds for extension of the contract time. If the Contractor has fulfilled all preliminary requirements for the issuance of a purchase order, and the purchase order authorization is not available by the date of availability, the Contractor shall be granted an extension equal to the number of calendar days the purchase order authorization is delayed after the date of availability.

PROSECUTION AND PROGRESS

The Contractor shall pursue the work diligently with workmen in sufficient numbers, abilities, and supervision, and with equipment, materials, and methods of construction as may be required to complete the work described in the contract by the completion date and in accordance with Section 108 of the *Standard Specifications*.

The Contractor's operations are restricted to daylight hours. No work may be performed on Sundays and legal State holidays. Work shall only be performed when weather and visibility conditions allow safe operations.

The Contractor shall temporarily remove his equipment from the travelway for emergency vehicles and school buses, and as directed by the Engineer.

DRIVEWAYS AND PRIVATE PROPERTY

The Contractor shall maintain access to driveways for all residents and property owners throughout the life of the project.

The Contractor shall not perform work for private citizens or agencies in conjunction with this project or within the project limits of this contract.

SMALL BUSINESS ENTERPRISE CONTRACT PROJECT SPECIAL PROVISIONS

FENCE INSTALLATION

GENERAL

This fence work along various routes in Hoke, Lee, Moore, Scotland and Richmond Counties will be designated by the Engineer. The amount of fence to be repaired will be a **minimum of 50 LF** of various types of fence before the Contractor is expected to mobilize to a county. Existing fence that cannot be satisfactorily reset using existing materials may be reset with new materials **supplied by the property owner.** The new fence shall be of like kind or similar to the existing fence; i.e., a woven wire fence should not be replaced with a board fence, etc. There may be multiple sites within a county, and the aggregate total repairs will be used to determine the minimum guaranteed quantity of 50 LF.

Incidental items such as fence removal, hardware, turn buckles, tie wire, etc. shall be considered incidental to the items indicated on the attached bid sheet. The line items included for Woven Wire Fence Replacement and Chain Link Fence Replacement shall be used as payment where the contractor is directed to install fence at locations that did not previously have fence.

Specifications

All materials and workmanship are to be in accordance with the latest *NCDOT Standard Drawings* and the latest *Standard Specifications for Roads and Structures*.

NOTIFICATION OF OPERATIONS

The Department of Transportation shall notify the Contractor of the requested work in writing, by phone, or by email.

The Contractor shall notify the Engineer 48 hours in advance of beginning work on this project. The Contractor shall give the Engineer sufficient notice of all operations for any sampling, inspection or acceptance testing required.

MOBILIZATION

Section 800 in the current Standard Specifications shall apply.

Payment will be made under:

COORDINATION WITH PROPERTY OWNERS

The County Maintenance Engineer will coordinate with the property owners in regard to fence materials for placement of new fence. The contractor shall make arrangements with the property owners that have livestock in fenced areas to contain the livestock with temporary enclosures, or by having the property owners move the livestock to another fenced location until the work is completed. The contractor will be responsible for any crop or property damage caused by livestock escaping or entering the existing fenced area through the negligence of his forces.

FENCE PAY ITEMS

Woven Wire Repair

Repair is defined as using existing components to place the fence in its original condition. For example, two posts might be pushed over but not broken and the woven wire and barbed wire are reusable. Payment items will be those listed "repair" items:

Barbed wire repair 30 LF (undamaged post to undamaged post)

47" woven wire repair 30 LF (undamaged post to undamaged post)

4" timber post repair 2 EA (damaged posts)

*Minimum payment will be the amount needed to repair 50 LF of fence based upon bid unit prices for "Repair": (50 LF barbed wire plus 50 LF woven wire plus 2 four-inch timber posts)

No separate payment will be made for #9 wire; and horizontal posts will be paid at the same rate as vertical posts without regard to length.

Woven Wire Replacement

Replacement is defined as using new components to place the fence in its original condition at a location indicated by the Engineer. For example, two posts might be broken and the woven wire and barbed wire are reusable. Payment items will be those listed under "repair" and "replacement".

*Minimum payment will be as previously described in the amount of 50 LF of fence "replacement". (50 LF barbed wire plus 50 LF woven wire plus four-inch timber posts)

No separate payment will be made for #9 wire and horizontal posts will be paid at the same rate as vertical posts without regard to length.

Chain Link Fence Repair/Reset

Repair is defined as using existing components to place the fence in its original condition at a location indicated by the Engineer. For example, two posts might be pushed over but not bent or broken and the chain link fence and tension wire are reusable. Payment items will be those listed "repair" items:

4' chain link fence repair 60 LF (undamaged post to undamaged post)

Tension wire 60 LF (undamaged post to undamaged post)

Line post repair 5 EA (damaged posts)

*Payment will be the amount needed to repair 60 LF of fence based upon bid unit prices for "Repair": (60 LF chain link fence plus 60 LF tension wire plus 5 line posts)

No separate payment will be made for #6 wire, stretcher bar bands, post caps, etc and horizontal posts will be paid at the same rate as vertical posts without regard to length.

The Contractor will be responsible for damage caused by livestock escaping or entering the existing fenced area through the negligence of his/her forces. If the owner of the fence desires to repair, rebuild or renew any parts of the fence and agrees to furnish the materials without cost to the Contractor, then repair, rebuild, renew and reset such fence using the material furnished by the owner at no additional cost to the owner or the Department.

Reset the fence in a condition that is equal to or better than before the fence is removed. Replace any of the fence components unnecessarily damaged by the Contractor's forces. Fill any void created by fence removal.

Fence Reset

Reset is defined as removing and resetting existing fences of various types to the locations indicated in the plans or where directed by the Engineer.

Reset the fence in a condition that is equal to or better than before the fence was removed. Replace any of the fence components unnecessarily damaged by the Contractor's forces. Fill any void created by fence removal.

The Contractor will be responsible for damage caused by livestock escaping or entering the existing fenced area through the negligence of his/her forces. If the owner of the fence desires to repair, rebuild or renew any parts of the fence and agrees to furnish the materials without cost to the Contractor, then repair, rebuild, renew and reset such fence using the material furnished by the owner at no additional cost to the owner or the Department.

Fence Reset will be measured and paid in the linear feet of fence that has been acceptably reset. Measurement will be made along the fence after it has been reset from center of end post to center of end post. Such price includes, but is not limited to, removing, hauling and re-erecting the existing fence; and furnishing and installing any fence components unnecessarily damaged by the Contractor's forces.

Payment will be made under:

Chain Link Fence Replacement

Replacement is defined as using new components to place the fence in its original condition. For example, five posts might be broken, chain link needs replacement, yet the tension wire is reusable. Payment items will be those listed under "repair" and "replacement".

Repair
Tension wire – 60 LF

A' Chain Link Fence – 60 LF
Line Post – 5 EA

*Payment will be the amount needed to replace 60 LF of fence based upon bid unit prices for "replacement" and "repair". (60 LF of 4' chain link fence replacement plus 60 LF tension wire repair plus 5 line posts replacement)

No separate payment will be made for #6 wire, stretcher bar bands, post caps, etc. and horizontal posts will be paid at the same rate as vertical posts without regard to length.

NOTE:

- 1. Under "replacement", quantity of wire (barbed, woven, chain link, and tension) will be the quantities actually needed.
- 2. Under "repair", quantity of wire (barbed, woven, chain link, and tension) will be measured from between posts where work is actually needed.

Pay Items

All components including but not limited to #6 wire, #9 wire, stretcher bar band, post caps, etc are to be included in other pay items since no separate payment will be made for these items, they are considered incidental to the repair or replacement of woven wire or chain link fence.

STANDARD SPECIAL PROVISIONS

AVAILIBILITY OF FUNDS – TERMINATION OF CONTRACTS

(5-20-08) Z 2

General Statute 143C-6-11. (h) Highway Appropriation is hereby incorporated verbatim in this contract as follows:

(h) Amounts Encumbered. – Transportation project appropriations may be encumbered in the amount of allotments made to the Department of Transportation by the Director for the estimated payments for transportation project contract work to be performed in the appropriation fiscal year. The allotments shall be multiyear allotments and shall be based on estimated revenues and shall be subject to the maximum contract authority contained in General Statute 143C-6-11(c). Payment for transportation project work performed pursuant to contract in any fiscal year other than the current fiscal year is subject to appropriations by the General Assembly. Transportation project contracts shall contain a schedule of estimated completion progress, and any acceleration of this progress shall be subject to the approval of the Department of Transportation provided funds are available. The State reserves the right to terminate or suspend any transportation project contract, and any transportation project contract shall be so terminated or suspended if funds will not be available for payment of the work to be performed during that fiscal year pursuant to the contract. In the event of termination of any contract, the contractor shall be given a written notice of termination at least 60 days before completion of scheduled work for which funds are available.
