The completion date for this contract is the date that is **One Hundred and Twenty (120)** consecutive calendar days after and including the date of availability.

Bids must be submitted on the official bid form and submitted with the entire proposal. Any bids received at the Division Office later than 2:00 p.m. on the date of the bid opening will be returned unopened. The following statement shall be displayed on the front of the bid envelope:


