# PLEASE READ ALL INSTRUCTIONS CAREFULLY BEFORE PREPARING AND SUBMITTING YOUR BID.

All bids shall be prepared and submitted in accordance with the following requirements. Failure to comply with any requirement may cause the bid to be considered irregular and may be grounds for rejection of the bid.

#### TRADITIONAL PAPER BIDS:

- Download the entire proposal from the Connect NCDOT website and return the entire proposal with your bid.
- 2. All entries on the itemized proposal sheet (bid form) shall be written in ink or typed.
- **3.** The Bidder shall submit a unit price for every item on the itemized proposal sheet. The unit prices for the various contract items shall be written in figures. Unit prices shall be rounded off by the Bidder to contain no more than TWO decimal places.
- **4.** An amount bid shall be entered on the itemized proposal sheet for every item. The amount bid for each item shall be determined by multiplying each unit bid by the quantity for that item, and shall be written in figures in the "Amount" column of the form.

#### AWARD OF CONTRACT

The award of the contract, if it be awarded, will be made to the lowest responsible Bidder in accordance with Section 102 (excluding 102-10) of the current edition of the *Standard Specifications for Roads and Structures*. The lowest responsible bidder will be notified that his bid has been accepted and that he has been awarded the contract. NCDOT reserves the right to reject any or all bids.

# **PROJECT SPECIAL PROVISIONS**

#### GENERAL

This contract is for work zone traffic control services as needed in Chatham, Montgomery, and Randolph Counties.

All work and materials shall be in accordance with the provisions of the General Guidelines of this contract, the Project Special Provisions, the current edition of the North Carolina Department of Transportation *Standard Specifications for Roads and Structures*, the current edition of the North Carolina Department of Transportation *Roadway Standards Drawings*, and the current edition of the *Manual of Uniform Traffic Control Devices* (MUTCD).

Wherever reference is given to codes, or standard specifications, or other data published by regulating agencies or accepted organizations, including but not limited to N.C. State Building Codes, Federal Specifications, ASTM Specifications, N.C. Department of Transportation 'Standard Specifications for Roads and Structures', and the like, it shall be understood that such reference is to the latest edition including addenda published prior to the date of the contract documents.

The Contractor shall keep himself fully informed of all Federal, State and local laws, ordinances, and regulations, and shall comply with the provisions of Section 107 of the *Standard Specifications*.

# **NON-EXCLUSIVE CONTRACT:**

The Department may, as it deems to be in the best interest of the State and the Department of Transportation, execute more than one contract based on this proposal. The Contractor(s) understands and agrees, by signature on the Purchase Order Contract Bid Form, that this agreement **does not** constitute an exclusive contract. If awarded, the contract(s) will be executed with the lowest responsible bidder(s). The Department of Transportation reserves the right to make multiple awards for the services provided by this contract. Furthermore, the Department reserves the right to reject all bids received.

# SMALL BUSINESS ENTERPRISE (MULTI-YEAR MAINTENANCE CONTRACTS): (4-20-21) SP1 G74

This contract is a multi-year maintenance contract let pursuant to the Small Business Enterprise provisions of N.C. General Statute §136-28.10. In accordance with N.C. General Statute §136-28.10, an award in a maintenance contract shall not exceed \$500,000 per year. This contract award is limited to \$500,000 per year. No payments in excess of this amount will be disbursed, in accordance with the Statute.

#### CONTRACT AND LIQUIDATED DAMAGES

1. <u>Term of the Contract-</u> The Contractor shall submit his/her bid for one year. At the option of the Department, this contract may be extended for two (2) additional periods of one (1) year each (maximum three (3) years total). No changes in the terms, conditions, etc. of this contract will be made when an extension to the contract is implemented, except that

there will be a clause to allow up to a maximum 3% increase in the existing contract unit prices. The Engineer will notify the Contractor in writing by May 1<sup>st</sup> if the contract may be extended. The Contractor must notify the Engineer in writing by May 15<sup>th</sup> of his/her acceptance or rejection of this offer. Failure on the part of the Contractor to reply will be received as a rejection of contract extension.

- 2. The date of availability for this project is UPON ISSUANCE OF PURCHASE ORDER. The Contractor will be notified in writing by the Engineer of job location and scope and shall begin work on the project within 14 days after this written notification or as determined by the Engineer. No work will be permitted and no purchase order will be issued until all prerequisite conditions and certifications have been satisfied.
- 3. The completion date for this project is <u>July 31, 2022</u>. If the term of the contract is extended, the date of availability in succeeding years will be August 1<sup>st</sup>, and the completion date will be July 31<sup>st</sup> each year. No extensions to the completion date will be authorized except as allowed by Article 108-10 of the *Standard Specifications*.
- 4. Liquidated damages for this contract are Three Hundred Fifty Dollars (\$350.00)) per calendar day for each calendar day when the Contractor fails to report to the project, which begins 14 calendar days after initial notification, or does not complete project deadlines as required by the County Maintenance Engineer.

# **BASIS OF AWARD:**

The Contractor is advised that this is an annual needs contract and that the quantities as shown on the bid form are estimates only. Actual quantities will be determined on an as needed basis. The quantities shown on the bid form will be used to establish unit prices for each line item and determination of low bid only. The Contractor shall submit a unit price for every item on the bid form. The Department reserves the right to increase or reduce quantities with no adjustment in unit prices.

<u>Unit prices should reflect actual costs; in accordance with Article 102-14, unbalanced bids may be rejected.</u>

Quotations will be evaluated based on the total bid of all items. There are no guarantees either stated or implied for the quantities as shown on the bid form. <u>Payment to the successful low bidder will be based on actual quantities of work performed and accepted at the PER UNIT PRICE for each item as quoted.</u>

The Department reserves the right to reject any or all bids.

# **PROSECUTION OF WORK**

The provisions of Section 108 shall apply with the following additions:

Upon notification by the Engineer, the Contractor shall begin work within fourteen (14) calendar days. Notification shall be by phone call, email, or letter and any of these methods shall be considered sufficient.

#### **SITE INVESTIGATION AND REPRESENTATION:**

(3-3-2014) 102-6 SPD 01-280

By signing the proposal documents, the Contractor acknowledges that:

- (A) He understands the nature of the work and general and local conditions, particularly those bearing on transportation;
- (B) He is familiar with the availability and cost of labor and materials;
- (C) He will to adhere to State regulations for safety and security of property, roads, and facilities;
- (D) He is able to prosecute the work in accordance with all applicable local, state and federal rules and regulations, and;
- (E) He has thoroughly investigated the project site(s).

Any failure on the part of the Contractor to acquaint himself with all available information shall not relieve him from the responsibility any aspect of the contracting process. No adjustment in contract time or contract prices will be made due to the Contractor's negligence in familiarizing himself with the contract or project site(s).

# LIABILITY INSURANCE:

(1-30-14) 107-15 SPD 01-550

Provide liability insurance in accordance with Article 107-15 of the 2018 Standard Specifications.

Revise the 2018 Standard Specifications as follows:

Page 1-64, Article 107-15 Liability Insurance, line 26, replace the first sentence of the fourth paragraph with the following:

Upon award of the contract, provide evidence of the above insurance requirements to the Engineer.

# **CONTRACTOR CLAIM SUBMITTAL FORM:**

If the Contractor elects to file a written claim or requests an extension of contract time, it shall be submitted on the *Contractor Claim Submittal Form (CCSF)* available through the Construction Unit or at <a href="https://connect.ncdot.gov/projects/construction/Pages/Construction-Resources.aspx">https://connect.ncdot.gov/projects/construction/Pages/Construction-Resources.aspx</a> as Form CCSF under Construction Forms.

Any claims for additional compensation and/or extensions of the completion date shall be submitted to the Division Engineer in writing, with detailed justification, prior to submitting the final invoice payment. Once an invoice is received and accepted that is marked as "Final", the Contractor shall be barred from recovery.

#### **TERMINATION OF CONTRACT:**

The Department reserves the right to terminate the contract if funds are unavailable, if the Engineer deems the Contractor's equipment is in disrepair, or any other reason deemed necessary.

# **AUTHORITY OF THE ENGINEER**

In accordance with Section 105 of the latest *Standard Specifications for Roads and Structures* and the following provisions: the Engineer for this project shall be the Division Engineer, Division 8, Division of Highways, North Carolina Department of Transportation, acting directly or through his/her duly authorized representatives.

The Engineer will decide all questions which may arise as to the quality and acceptability of work performed and as to the rate of progress of the work; all questions which may arise as to the interpretation of the contract; and all questions as to the acceptable fulfillment of the contract on the part of the Contractor. His decision shall be final and he shall have executive authority to enforce and make effective such decisions and orders as the Contractor fails to carry out promptly

# **SUBLETTING OF CONTRACT**

In accordance with Section 108, the Contractor is reminded that he/she shall not sublet, sell, transfer, assign, or otherwise dispose of the contract or any portion thereof; or of his/her right, title, or interest therein; without written consent of the Engineer.

# **CONTACT PERSONS**

The office hours for all County Maintenance offices are 7:00 AM to 3:30 PM Monday through Friday.

#### **EXTENSION OF CONTRACT TIME**

Failure on the part of the Contractor to furnish bonds or certifications or to satisfy preliminary requirements necessary to issue the purchase order will not constitute grounds for extension of the contract time. If the Contractor has fulfilled all preliminary requirements for the issuance of a purchase order, and the purchase order authorization is not available by the date of availability, the Contractor shall be granted an extension equal to the number of calendar days the purchase order authorization is delayed after the date of availability.

#### PROSECUTION AND PROGRESS:

(3-16-10) 108 SPD 1-700

The Contractor shall pursue the work diligently with workmen in sufficient numbers, abilities, and supervision, and with equipment, materials, and methods as may be required to complete the work described in the contract by the completion date and in accordance with the 2018 Standard Specifications.

The Contractor's operations are restricted to daylight hours. No work may be performed on Sundays and legal State holidays, unless otherwise approved by the Engineer. Work shall only be performed when weather and visibility conditions allow safe operations.

# **SUPERVISION BY CONTRACTOR:**

At all times during the life of the project the Contractor shall provide one permanent employee who shall have the authority and capability for overall responsibility of the project and who shall be personally available at the work site within 24 hours notice. Such employee shall be fully authorized to conduct all business with the subcontractors, to negotiate and execute all supplemental agreements, and to execute the orders or directions of the Engineer.

At all times that work is actually being performed, the Contractor shall have present on the project one competent individual who is authorized to act in a supervisory capacity over all work on the project, including work subcontracted. The individual who has been so authorized shall be experienced in the type of work being performed and shall be fully capable of managing, directing, and coordinating the work; of reading and thoroughly understanding the contract; and receiving and carrying out directions from the Engineer or his authorized representatives. He shall be an employee of the Contractor unless otherwise approved by the Engineer.

The Contractor may, at his option, designate one employee to meet the requirements of both positions. However, whenever the designated employee is absent from the work site, an authorized individual qualified to act in a supervisory capacity on the project shall be present.

# **SAFETY AND ACCIDENT PROTECTION:**

In accordance with Article 107-21 of the Standard Specifications, the Contractor shall comply with all applicable Federal, State, and local laws, ordinances, and regulations governing safety, health, and sanitation, and shall provide all safeguards, safety devices, and protective equipment, and shall take any other needed actions, on his own responsibility that are reasonably necessary to protect the life and health of employees on the job and the safety of the public, and to protect property in connection with the performance of the work covered by the contract.

#### **SAFETY VESTS**

All Contractors' personnel, all subcontractors and their personnel, and any material suppliers and their personnel must wear an OSHA approved or MUTCD Class II (Class III at night) reflective vest or outer garment at all times while on the project.

The Contractor shall comply with all applicable Federal, State, and local laws, ordinances, and regulations governing safety, health, and sanitation, and shall provide all safeguards, safety devices, and protective equipment, and shall take any other needed actions, on his own responsibility that are reasonably necessary to protect the life and health of employees on the job and the safety of the public, and to protect property in connection with the performance of the work covered by the contract.

Failure to comply with any of the requirements for safety and traffic control of this contract shall result in suspension of work as provided in subarticle 108-7(B) of the Standard Specifications.

# **EQUIPMENT IDLING GUIDELINES:**

(1-19-21) 10

SP1 G096

Exercise reduced fuel consumption and reduced equipment emissions during the construction of all work associated with this contract. Employees engaged in the construction of this project should turn off vehicles when stopped for more than thirty (30) minutes and off-highway equipment should idle no longer than fifteen (15) consecutive minutes.

These guidelines for turning off vehicles and equipment when idling do not apply to:

- 1. Idling when queuing.
- 2. Idling to verify the vehicle is in safe operating condition.
- 3. Idling for testing, servicing, repairing or diagnostic purposes.
- 4. Idling necessary to accomplish work for which the vehicle was designed (such as operating a crane, mixing concrete, etc.).
- 5. Idling required to bring the machine system to operating temperature.
- 6. Emergency vehicles, utility company, construction, and maintenance vehicles where the engines must run to perform needed work.
- 7. Idling to ensure safe operation of the vehicle.
- 8. Idling when the propulsion engine is providing auxiliary power for other than heating or air conditioning. (such as hydraulic systems for pavers)
- 9. When specific traffic, safety, or emergency situations arise.
- 10. If the ambient temperature is less than 32 degrees Fahrenheit. Limited idling to provide for the safety of vehicle occupants (e.g. to run the heater).
- 11. If the ambient temperature is greater than 90 degrees Fahrenheit. Limited idling to provide for the safety of vehicle occupants of off-highway equipment (e.g. to run the air conditioning) no more than 30 minutes.
- 12. Diesel powered vehicles may idle for up to 30 minutes to minimize restart problems.

Any vehicle, truck, or equipment in which the primary source of fuel is natural gas or electricity is exempt from the idling limitations set forth in this special provision.

# **UTILITY CONFLICTS**

Special care shall be used in working around or near existing utilities, protecting them when necessary to provide uninterrupted service. In the event that any utility service is interrupted, the Contractor shall notify the utility owner immediately and shall cooperate with the owner, or his representative, in the restoration of service in the shortest time possible. Existing fire hydrants shall be kept accessible to fire departments at all times.

The Contractor shall adhere to all applicable regulations and follow accepted safety procedures when working in the vicinity of utilities to ensure the safety of construction personnel and the public.

# **DRIVEWAYS AND PRIVATE PROPERTY**

The Contractor shall maintain access to driveways for all residents and property owners throughout the life of the project.

The Contractor shall not perform work for private citizens or agencies in conjunction with this project or within the project limits of this contract.

# PAYMENT AND RETAINAGE

Payment will be made at the contract unit price. Prices and payment will be full compensation for all work covered. All work items necessary to complete the work other than listed on the "Bid Form" will be considered incidental in nature and no further compensation will be made. Any work performed in an unsatisfactory manner could be a basis for cancellation of the contract.

The Contractor may submit a request for partial payment on a monthly basis, or other interval as approved by the Engineer. The amount of partial payments will be based on the work accomplished and accepted as the last day of the approved pay period. One hundred percent (100%) payment shall be made after successful completion of the work and all quantities have been verified. The invoices will show the requisition number and purchase order number and should state "Terms Net Ten (10) Days". There will be no retainage held on this project.

# SMALL BUSINESS ENTERPRISE CONTRACT PROJECT SPECIAL PROVISIONS

# TRAFFIC CONTROL SERVICES

The Contractor shall provide Traffic Control Services in accordance with these specifications and as directed by the Engineer. The Engineer will identify the location where the Contractor will provide Traffic Control. The Engineer or his/her duly authorized representative will monitor the Contractor's operations on a periodic basis to assure compliance with proper traffic control procedures.

The Contractor shall furnish a crew of one qualified supervisor and three qualified flaggers (see *NCDOT Roadway Standard Drawing* No. 1150.01), a truck, and a trailer. The truck shall be equipped with approved flashing amber light bar not less than 20 inches in length. The truck shall be suitable for transporting the Contractor's personnel and towing the loaded trailer. The trailer shall be of sufficient size to transport the necessary signs, cones, barrels, and other traffic control devices deemed necessary to provide the required traffic control operation. Additional flaggers may be required as directed by the Engineer and paid for under Additional Certified Flagger(s), per hour.

The Contractor shall furnish all signs, cones, barrels, barricades, and stop/slow paddles required for the traffic control operation. In addition, the Contractor shall furnish four (4) two-way radios for the use in controlling traffic. The Contractor shall maintain the radios and have them available on the project at all times. All Contractor personnel must wear an OSHA approved reflective vest or outer garment at all times while on the project. Payment for Additional Certified Flagger(s) shall include all equipment needed to provide additional flagger service including but not limited to additional two-way radios.

The Contractor's traffic control crew shall report to the appropriate project site with truck and trailer at the time specified by the Engineer. The Contractor shall maintain the traffic control operation in a continuous and uninterrupted manner until instructed by the Department's representative to remove the traffic control devices. When instructed by the Department's representative, the Contractor shall remove the traffic control devices and load the devices on his/her trailer. If traffic control is required at another location on the project or at another project site, the Contractor shall transport the traffic control devices and re-establish traffic control at the new location as directed by the Department's representative. At the end of the workday, the Contractor shall load the traffic control devices on his/her trailer. If the Department requires traffic control services on the following workday, the Contractor shall store his/her trailer in a secure location.

At the direction of the Engineer, temporary signs may be required to remain on the project for short durations (approximately one week). The Contractor shall be responsible for installation and removal of any such signs that may be required.

**Stationary work zone signs and barricades** may be required by the Engineer for the life of a project entailing road closures and detours. These signs and barricades shall be provided as directed by the Engineer. The Contractor shall be responsible for installation, maintenance, and removal of any such signs and barricades per NCDOT Roadway Standard Drawings 1110.01,

and 1145.01, current NCDOT Standard Specifications for Roads and Structures, the current Manual on Uniform Traffic Control Devices, and as directed by the Engineer. Stationary work zone signs and barricades for road closures shall be paid for under Barricades, Type III, and Work Zone Signs, Stationary.

DEPARTMENT PERSONNEL SHALL PROVIDE DIRECTION AS TO THE LOCATION, LAYOUT, AND METHOD OF TRAFFIC CONTROL REQUIRED. TEMPORARY LANE CLOSURES SHALL BE IN ACCORDANCE WITH THE NCDOT ROADWAY STANDARD DRAWING NUMBER 1101.02 REQUIREMENTS. ROAD CLOSURE SIGNS, DETOUR SIGNS AND BARRICADES SHALL BE IN ACCORDANCE WITH NCDOT ROADWAY STANDARD DRAWING NUMBER 1101.03 REQUIREMENTS

Temporary shoulder closures shall be in accordance with the NCDOT Roadway Standard Drawing Number 1101.04. Flaggers stationed at each end of the work zone shall control traffic movements through lane closures on roads with two-way traffic. In situations where sight distance is limited, the Contractor will provide two-way radios so the flagmen can communicate with each other. In addition, on high volume roads or other situations as determined by the Engineer, a Pilot Vehicle will be used to move traffic through the work zone. This vehicle shall be operated by a licensed laborer. The vehicle shall be in good working condition and display a working amber strobe light at all times during operation. The vehicle shall also display signing on the rear of the vehicle stating "Pilot Vehicle, Follow Me" as shown in Standard Drawing 1101.02. Flagmen shall be competent personnel, adequately trained in flagging procedures. Flagmen shall utilize proper safety devices and equipment, including but not limited to safety vests and stop/slow paddles. The Contractor's supervisor shall provide relief for the primary flagmen periodically during the workday.

The Contractor shall comply with all applicable Federal, State, and local laws, ordinances, and regulations governing safety, health, and sanitation. The Contractor shall take any other needed actions that are reasonably necessary to protect the life and health of employees on the job and the safety of the public, and to protect property in connection with the performance of the work covered by the contract.

Failure by the Contractor or its personnel to comply with any of the provisions of this contract or instructions given by the Engineer or his duly authorized representative with regard to traffic control operation or the safety of job site personnel or the public shall result in suspension of work and may result in termination of the contract.

Compensation for providing traffic control will be made at the contract unit price per hour for "Traffic Control Services". Such payment will be full compensation for all work covered by this section (unless otherwise specified) including, but not limited to, furnishing a crew consisting of one qualified supervisor and three qualified flagmen, a suitable truck and trailer, signs, and stop/slow paddles required for the traffic control operation throughout the project limits, installing, maintaining, relocating and removing all traffic control devices as directed by the Engineer and conducting the traffic control operation in a manner that will be safe for the traveling public, the contractor, and Department personnel on the job site. Time will be started when the traffic control crew arrives on the job site. Time will stop when the traffic control crew leaves from the job site.

The Engineer or his/her duly authorized representative will maintain a time sheet. The Department's representative and the Contractor's supervisor shall review and agree on the recorded time on the daily basis. The hours worked shall be recorded to the nearest ¼ hour.

# **SUPERVISION BY CONTRACTOR**

At all times during the life of the project the Contractor shall provide one permanent employee who shall have the authority and capability for overall responsibility of the project and who shall be personally available at the work site within 24 hours notice. Such employee shall be certified under NCDOT approved Work Zone Supervisor Certification course, and fully authorized to conduct all business with the subcontractors, to negotiate and execute all supplemental agreements, and to execute the orders or directions of the Engineer.

At all times that work is actually being performed, the Contractor shall have present on the project competent individual who is authorized to act in a supervisory capacity over all work on the project, including work subcontracted. The individual who has been so authorized shall be experienced in the type of work being performed and shall be fully certified and capable of managing, directing, and coordinating the work; of reading and thoroughly understanding the contract; and receiving and carrying out directions from the Engineer or his/her authorized representatives. He/she shall be an employee of the Contractor unless otherwise approved by the Engineer.

The Contractor may, at his/her option, designate one employee to meet the requirements of both positions. However, whenever the designated employee is absent from the work site, an authorized individual qualified to act in a supervisory capacity on the project shall be present.

#### WORK ZONE SUPERVISOR CERTIFICATION

All personnel in charge of overseeing work zone temporary traffic control operations and installations inside the highway right of way will be trained in an NCDOT approved Work Zone Supervisor Course. Each will be required to have 2 years of traffic control experience in flagging and lane closure installation. It is the responsibility of each employer to ensure accurate records are maintained.

The Work Zone Supervisor shall ensure all employees who perform traffic control duties on the project have the proper training and certifications to perform the work safely and accurately.

# Recertification Requirements

Work Zone Supervisors shall be recertified every 4 years. The date is based on when they were issued their certification (card or certificate) from the approved training agency or company.

Companies that perform internal training for their employees can self-certify their employees provided they have a Department approved trainer, course, and examination.

# **Trainer Requirements**

- 1. 3 years' experience in the road construction industry. Examples of qualifying industry experience include but not limited to the following:
  - a. Construction Foreman, Superintendent, Project Engineer, Project Manager
  - b. Flagging, Traffic Control Installation, and/or Pavement Marking Installation
  - c. Equipment Operator, Material Testing/Inspection and/or Utility work within highway R/W
  - d. Company Safety Officer or similar position knowledgeable in roadside safety.
  - e. Construction Engineering and/or Designing or Developing Temporary Traffic Control Plans and details
- 2. Completion of an approved Work Zone Supervisor course including a passing score on the exam.

# **Course Content Summary**

Division 11 of the Standard Specifications and Roadway Standard Drawings, Rural and Interstate Resurfacing Requirements, proper methods/best practices of installation/removal of lane closures and road closures, Changeable message signs, work zone presence lighting, Digital Speed Limit Signs, Sequential Flashing Lights, High Visibility Devices, portable traffic signals/AFADs, Transportation Management Plans (TMP).

#### WORK ZONE FLAGGER CERTIFICATION

All personnel involved with flagging operations and all personnel participating in installation and removal of temporary traffic control regardless of whether flagging is part of the operation will be trained in an NCDOT approved flagger course. It is the responsibility of each employer to ensure accurate records are maintained.

# Recertification Requirements

Work Zone Flaggers shall be recertified every 4 years. The date is based on when they were issued their certification card.

#### **Self-Certification**

Companies that perform internal training for their employees can self-certify their employees provided they have a Department approved trainer, course, and examination.

# **Trainer Requirements**

Self-certifying trainer requirements same as Work Zone Supervisor.

#### Course Content

Roadway Standard Drawing 1101.02, sheets 1 and 2, proper methods/best practices of flagging traffic for standard lane closures on 2 lane roadways, haul road crossings, and shoulder operations where lanes are open, personal protective equipment, communicating

with public, proper positioning, hand signaling, escape, and night flagging. A comprehensive description of the minimum course requirements and exam requirements will be posted to the Connect NCDOT Work Zone Safety Training webpage

#### Exam

Must have a minimum of 20 questions on the above requirements. A passing score is 70 or above and retesting is permitted.

# **WORK ZONE INSTALLER CERTIFICATION**

At least one member of every crew responsible for setup, installation, and removal of traffic control devices within any highway right of way shall be trained and certified as a Work Zone Installer. The certified Work Zone Installer should serve as crew leader and shall be on site and directing the installation and removal of temporary traffic control.

All other members of the crew shall be certified flaggers, even if flagging is not being performed as part of the traffic control.

The Work Zone Installer does not replace or change the requirements of a Work Zone Supervisor as described in article 1101-13 of the Standard Specifications.

Training for this certification is provided by NCDOT approved training resources and by private entities that have been pre-approved to train themselves. It is the responsibility of each employer to ensure accurate records are maintained.

# Recertification Requirements

Work Zone Installers shall be recertified every 4 years. The date is based on when they were issued their certification card from the approved training agency or employer.

#### Self-Certification

Companies that perform internal training for their employees can self-certify their employees provided they have a Department approved trainer, course, and examination.

# **Trainer Requirements**

Self-certifying trainer requirements same as Work Zone Supervisor.

#### Course Content

Fundamentals of Temporary Traffic Control, Common Traffic Control Devices, Typical

TTC Set Ups, Flagging Operations with best practices for safe installation and removal. A comprehensive description of the minimum course requirements and exam requirements will be posted to the Connect NCDOT Work Zone Safety Training webpage.

#### Exam

Must have a minimum of 25 questions on the above requirements. A passing score is 70 or above and retesting is permitted.

# **NEW - WORK ZONE EDUCATION VERIFICATION APP**

The Department has launched a training records database, named the Work Zone Education Verification App (WZ-EVA) to allow our inspectors and resident engineers to quickly verify training credentials of work zone flaggers, installers, and supervisors in the field. Once an individual completes an approved training course, approved trainers will be required to upload training certifications to WZ-EVA and issue official wallet cards which are generated by the WZ-EVA system. NCDOT will not provide printed wallet cards except for workers with Virginia or South Carolina certifications as described later in this document.

Upon award of contract and before work begins, the contractor shall provide the Engineer the Work Zone certifications with expiration dates for employees by providing copies of the official wallet cards printed from the WZ–EVA.

#### **Description**

Install and maintain signing in accordance with Divisions 11 and 12 of the *Standard Specifications*, the *Roadway Standard Drawings* and the following provisions:

Furnish, install, maintain, and remove advance warning work zone signs and any required lane closure signing.

#### **Construction Methods**

# (A) General

Install all warning work zone signs before beginning work. If signs are installed three days prior to the beginning of work, cover the signs until the work begins. Install each work zone warning sign separately and not on the same post or stand with any other sign except where an advisory speed plate or directional arrow is used.

# (B) Advance Warning Work Zone Signs

Install advance warning work zone signs (see attached Details and the *Roadway Standard Drawings* Nos. 1101.02 and 1110.01 and advance signing details) prior to beginning of work and remove upon final completion of the project. If there is a period of construction inactivity longer than two weeks, remove or cover advance warning work zone signs. Uncover advance warning work zone signs no more than three (3) days before work resumes. All other operations could be suspended upon failure

to comply with the above requirements. Such suspended operations would not be resumed until the above requirements are fulfilled.

# (C) Lane Closure Work Zone Signs

Install any required lane closure signing needed during the life of the project in accordance with the *Roadway Standard Drawings* Nos. 1101.02, 1101.11 and 1110.02.

# PRESERVATION OF PROPERTY

The Contractor shall exercise care to avoid damage to all public and private property and facilities. Any damage to properties, such as, but not limited to, mailboxes, fences, gates, vehicles, driveways, etc. shall immediately be restored to the previously existing condition. No payment will be made to the Contractor for such restorative work.

The Contractor shall be responsible for the equipment provided in this contract at all times and at all locations during the term of the contract. The Contractor shall have no claim against the Department of Transportation for any expense involving damage or loss to the Contractor's equipment (including vandalism, theft, fire and acts of God) arising out of, or relating to, work performed under this agreement.

The allotments shall be multiyear allotments and shall be based on estimated revenues and shall be subject to the maximum contract authority contained in General Statute 143C-6-11(c). Payment for transportation project work performed pursuant to contract in any fiscal year other than the current fiscal year is subject to appropriations by the General Assembly. Transportation project contracts shall contain a schedule of estimated completion progress, and any acceleration of this progress shall be subject to the approval of the Department of Transportation provided funds are available. The State reserves the right to terminate or suspend any transportation project contract, and any transportation project contract shall be so terminated or suspended if funds will not be available for payment of the work to be performed during that fiscal year pursuant to the contract. In the event of termination of any contract, the contractor shall be given a written notice of termination at least 60 days before completion of scheduled work for which funds are available. In the event of termination, the contractor shall be paid for the work already performed in accordance with the contract specifications.

Payment will be made on any contract terminated pursuant to the special provision in accordance with Subarticle 108-13(E) of the 2018 Standard Specifications.

The provisions of this section related to United States Department of Transportation (US DOT) Order 1050.2A, Title 49 Code of Federal Regulations (CFR) part 21, 23 United States Code (U.S.C.) 140 and 23 CFR part 200 (or 49 CFR 303, 49 U.S.C. 5332 or 49 U.S.C. 47123) are applicable to all North Carolina Department of Transportation (NCDOT) contracts and to all related subcontracts, material supply, engineering, architectural and other service contracts, regardless of dollar amount. Any Federal provision that is specifically required not specifically set forth is hereby incorporated by reference.

# (1) Title VI Assurances (USDOT Order 1050.2A, Appendix A)

During the performance of this contract, the contractor, for itself, its assignees, and successors in interest (hereinafter referred to as the "contractor") agrees as follows:

# (a) Compliance with Regulations

- 4. Physically incorporate the FHWA-1273, in its entirety, into all subcontracts and subsequent lower tier subcontracts on Federal-aid highway construction contracts only.

# **ON-THE-JOB TRAINING**

# **Description**

The North Carolina Department of Transportation will administer a custom version of the Federal On-the-Job Training (OJT) Program, commonly referred to as the Alternate OJT Program. All contractors (existing and newcomers) will be automatically placed in the Alternate Program. Standard OJT requirements typically associated with individual projects will no longer be applied at the project level. Instead, these requirements will be applicable on an annual basis for each contractor administered by the OJT Program Manager.

On the Job Training shall meet the requirements of 23 CFR 230.107 (b), 23 USC – Section 140, this provision and the On-the-Job Training Program Manual.

The Alternate OJT Program will allow a contractor to train employees on Federal, State and privately funded projects located in North Carolina. However, priority shall be given to training employees on NCDOT Federal-Aid funded projects.

#### **Minorities and Women**

Developing, training and upgrading of minorities and women toward journeyman level status is a primary objective of this special training provision. Accordingly, the Contractor shall make every effort to enroll minority and women as trainees to the extent that such persons are available within a reasonable area of recruitment. This training commitment is not intended, and shall not be used, to discriminate against any applicant for training, whether a member of a minority group or not.

# **Assigning Training Goals**

The Department, through the OJT Program Manager, will assign training goals for a calendar year based on the contractors' past three years' activity and the contractors' anticipated upcoming year's activity with the Department. At the beginning of each year, all contractors eligible will be contacted by the Department to determine the number of trainees that will be assigned for the upcoming calendar year. At that time the Contractor shall enter into an agreement with the Department to provide a self-imposed on-the-job training program for the calendar year. This agreement will include a specific number of annual training goals agreed to by both parties. The number of training assignments may range from 1 to 15 per contractor per calendar year. The Contractor shall sign an agreement to fulfill their annual goal for the year.\

# **Training Classifications**

The Contractor shall provide on-the-job training aimed at developing full journeyman level workers in the construction craft/operator positions. Preference shall be given to providing training in the following skilled work classifications:

Equipment Operators Office Engineers

Truck Drivers Estimators

Carpenters Iron / Reinforcing Steel Workers

Concrete Finishers Mechanics
Pipe Layers Welders

The Department has established common training classifications and their respective training requirements that may be used by the contractors. However, the classifications established are not all-inclusive. Where the training is oriented toward construction applications, training will be allowed in lower-level management positions such as office engineers and estimators. Contractors shall submit new classifications for specific job functions that their employees are performing. The Department will review and recommend for acceptance to FHWA the new classifications proposed by contractors, if applicable. New classifications shall meet the following requirements:

Proposed training classifications are reasonable and realistic based on the job skill classification needs, and

The number of training hours specified in the training classification is consistent with common practices and provides enough time for the trainee to obtain journeyman level status.

The Contractor may allow trainees to be trained by a subcontractor provided that the Contractor retains primary responsibility for meeting the training and this provision is made applicable to the subcontract. However, only the Contractor will receive credit towards the annual goal for the trainee.

Where feasible, 25 percent of apprentices or trainees in each occupation shall be in their first year of apprenticeship or training. The number of trainees shall be distributed among the work classifications on the basis of the contractor's needs and the availability of journeymen in the various classifications within a reasonable area of recruitment.

No employee shall be employed as a trainee in any classification in which they have successfully completed a training course leading to journeyman level status or in which they have been employed as a journeyman.

#### **Records and Reports**

The Contractor shall maintain enrollment, monthly and completion reports documenting company compliance under these contract documents. These documents and any other information as requested shall be submitted to the OJT Program Manager.

Upon completion and graduation of the program, the Contractor shall provide each trainee with a certification Certificate showing the type and length of training satisfactorily completed.

#### **Trainee Interviews**

All trainees enrolled in the program will receive an initial and Trainee/Post graduate interview conducted by the OJT program staff.

# **Trainee Wages**

Contractors shall compensate trainees on a graduating pay scale based upon a percentage of the prevailing minimum journeyman wages (Davis-Bacon Act). Minimum pay shall be as follows:

60 percent	of the journeyman wage for the first half of the training period
75 percent	of the journeyman wage for the third quarter of the training period
90 percent	of the journeyman wage for the last quarter of the training period

In no instance shall a trainee be paid less than the local minimum wage. The Contractor shall adhere to the minimum hourly wage rate that will satisfy both the NC Department of Labor (NCDOL) and the Department.

# **Achieving or Failing to Meet Training Goals**

The Contractor will be credited for each trainee employed by him on the contract work who is currently enrolled or becomes enrolled in an approved program and who receives training for at least 50 percent of the specific program requirement. Trainees will be allowed to be transferred between projects if required by the Contractor's scheduled workload to meet training goals.

If a contractor fails to attain their training assignments for the calendar year, they may be taken off the NCDOT's Bidders List.

# **Measurement and Payment**

No compensation will be made for providing required training in accordance with these contract documents.
