Addendum #2 -

Type A & B in Forsyth and Guilford Counties.

This letter is to advise all prospective bidders of the following contract addendum.

• Change "Day and Time Restrictions" from 9 am − 4 pm to 4 pm − 9 am on page 7 of the contract proposal.

This addendum officially becomes part of the contract.

### INTERMEDIATE CONTRACT TIME NUMBER 1 AND LIQUIDATED DAMAGES:

(2-20-07) 108 SP1 G14 A

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on I-40 and I-74/US 311 during the following time restrictions unless otherwise approved by the Engineer:

### DAY AND TIME RESTRICTIONS

Monday - Thursday

4pm - 9am

## **NO Lane Closures on Friday**

In addition, the Contractor shall not close or narrow a lane of traffic on I-40 and I-74/US 311, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

#### HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

- 1. For **unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.
- 2. For New Year's Day, between the hours of 6am December 31st and 11pm January 2nd. If New Year's Day is on a Friday, Saturday, Sunday or Monday, then until 11pm the following Tuesday.
- 3. For **Easter**, between the hours of **6am** Thursday and **11pm** Monday.
- 4. For **Memorial Day**, between the hours of **6am** Friday and **11pm** Tuesday.
- 5. For **Independence Day**, between the hours of **6am** the day before Independence Day and **11pm** the day after Independence Day.
  - If **Independence Day** is on a Friday, Saturday, Sunday or Monday, then between the hours of **6am** the Thursday before Independence Day and **11pm** the Tuesday after Independence Day.
- 6. For Labor Day, between the hours of 6am Friday and 11pm Tuesday.
- 7. For **Thanksgiving Day**, between the hours of **6am** Tuesday and **11pm** Monday.
- 8. For Christmas, between the hours of 6am the Friday before the week of Christmas Day and 11pm the following Tuesday after the week of Christmas Day.

Holidays and holiday weekends shall include New Year's, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. The Contractor shall schedule his work so that lane closures are not required during these periods, unless otherwise directed by the Engineer.

The time of availability for this intermediate contract work shall be the time the Contractor begins to install all traffic control devices for lane closures according to the time restrictions listed herein.

The completion time for this intermediate contract work shall be the time the Contractor is required to complete the removal of all traffic control devices for lane closures according to the time restrictions stated herein and place traffic in the existing traffic pattern.

The liquidated damages are One Thousand Dollars (\$1,000.00) per hour.
