Bids must be submitted on the official bid sheet included in the proposal. The following statement must be prominently displayed on the front of the envelope:

The North Carolina Department of Transportation, in accordance with the provision of Title VI of the Civil Rights Act of 1964 (78 Stat. 252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

MANDATORY PRE-BID CONFERENCE AND PROPOSAL REVIEW

In order to bid on this contract, all prospective bidders shall attend a Mandatory Pre-Bid Conference, broken into two segments. The first segment will be held **on site at the Alligator River Bridge on US 64 in Tyrrell County and will begin promptly at 10:00 a.m. on Thursday, January 3, 2013.**

The second segment will be held **at the NCDOT Division One Office, 113 Airport Drive, Suite 100, Edenton, NC 27932, located approximately 5 miles southeast of Edenton, just off NC 94 on Airport Drive in the Northeastern Regional Airport Building at 2:00 p.m. on Thursday, January 3, 2013. The pre-bid conference will include a thorough discussion of the plans, contract pay items, special provisions, etc.

Statement of Minority Business Enterprise and Women Business Enterprise participation must be presented with the bids.

The Department reserves the right to reject any and/or all bids.
