**Item 2: Bid Clarification:**

A question was raised concerning the section of the contract near the bottom of page 34 of the contract that reads: Cleanup of plant beds required as a result of storm damage (i.e., ice storms, snow, car crashes, etc.). The removal of trees, limbs, etc. from wind/rain storms shall be cleaned up following a storm. **No additional compensation will be made for any additional cleanup as a result of these types of damages.**

It was agreed upon that the contractor will be responsible for cleanup of any planted trees that are 4 inches or less in diameter and that the NC DOT will be responsible for any planted trees that are larger than 4 inches in diameter measured along the trunk.

**Item 3: Questions and Answers:**

- Q: A question was raised concerning litter pickup – what areas would the contractor be responsible for?
- A: The contractor is responsible for litter pickup of the plant bed areas only. We do not expect the contractor to pick up entire quadrants of litter only where the mulched plant beds are located.
- Q: A question was raised concerning the Planting of Replacement Plants. How would these sq. yds. be figured?
- A: The mulched area of the planted site will be measured in sq. yds., for figuring the rate of compensation to the contractor. Example – Contractor bids \$10/sq. yd. for replacement plants - if a 100 sq. yd. area is being planted with 1 – 15 gallon tree than the contractor would receive \$1,000. If the same 100 sq. yd. area is being planted with 50 – 3 gallon junipers the contractor would receive \$1,000.
