Ground Effects, Inc.	\$2,000.00


- Once the contract is executed, please furnish two (2) hard copies of executed contract and two (2) hard copies of final plans plus any addenda to my attention.

When requesting reimbursement from NCDOT, please provide the Subcontractor Payment Report (DBE-IS) with every invoice so that Department can accurately track payments made to DBE subcontractors. Also, a Sales Tax statement must be included and deducted from the invoiced amount.
