### **PROJECT NAME:** U4713B – Campus Ridge Road Realignment

Pursuant to NC General Statutes 143-129, sealed bids will be received by the Town of Matthews for the furnishing of all materials, labor, equipment and construction of the U4713B – Campus Ridge Road Realignment, consisting of one contract having the following principal items:

U4713B – Campus Ridge Road Realignment consists of construction of extending McKee Road from East John Street (SR 1009) to Campus Ridge Road (SR 3457), a distance of approximately 0.4 miles. The project will also realign Campus Ridge Road on the east end.

Sealed bids should be submitted to the attention of: Mr. Ralph Messera, Matthews Public Works, 1600 Tank Town Road, Matthews, NC, 28105, and marked "U4713B - Campus Ridge Road Realignment"

Contractors must be pre-qualified as a Bidder or PO Prime Contractor prior to bidding on this project. Information about prequalification can be found at <https://connect.ncdot.gov/business/prequal/pages/default.aspx>

Mailed bids will be received at the Town of Matthews, 1600 Tank Town Road, Matthews, North Carolina, until 1:59 p.m. on April 30, 2015. Hand delivered bids on the day of bid opening will be received at the Town of Matthews, Jordan Room, Matthews Town Hall, 232 Matthews Station Street, until 2:00 p.m. on April 30, 2015 at which time, the BIDS will be publicly opened and read aloud.

A Bid Security in the amount of five percent (5%) of the proposed overall bid amount must accompany each proposal in order to be considered. The Bid security may be in the form of cash, a certified check or bank draft payable to the Town of Matthews, a Bid Bond executed by the Bidder or an acceptable Surety Agency consented to conduct business in North Carolina. No Bid may be withdrawn for a period of ninety (90) days from the date of bid opening except as may be allowed under North Carolina General Statutes.
