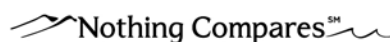
It will be the Contractor's responsibility to continue to monitor the NCDOT website for any addendums or other updates concerning this project.


