NOTE: There will be a Mandatory Pre-Bid at 10:00 AM Wednesday May 21, 2014 at the Traffic Services Office located at 903 Coble Ave. Albemarle, NC 28001. Only Contractors who attend this Pre-Bid will be able to bid on this project.

Bids must be submitted on the official bid sheet, submitted with the entire proposal, and display the following statement at the bottom left corner of the sealed envelope:
