D. E. Walker Construction Company has been awarded the above project. Your bid proposal indicated adequate participation to satisfy the advertised MBE goal of 0.0% and WBE goal of 5.0%.

Based on your bid proposal, the Department has approved the following prequalified MBE and WBE subcontractors and dollar amounts to meet the contract goal requirements. These firms are required to be utilized under the regulations in the Special Provision contained in the contract proposal. Any changes in the work affecting an MBE or WBE firm or replacement of a MBE or WBE firm will need to follow the appropriate steps as outlined in these provisions.

2. A Certificate of Public Liability and Property Damage Insurance for the coverage as stated in Section 107-15 of the NCDOT Standard Specifications. This certificate must include the NC Department of Transportation as an additional insured on the policy.
3. A Letter of Intent for each certified MBE or WBE subcontractor listed and approved for the contract.
