SHOULDER CONSTRUCTION

Description

Shoulder construction is the construction of a new shoulder due to asphalt wedging to correct super elevation on the existing roadway from 10+11.86 -L- to 16+76.97 -L-. Place earth material along the completed edge of pavement and construct shoulders as shown on Typical Section No. 1 and/or as directed by the Engineer. Backfill and compact the area to the satisfaction of the Engineer.

Materials

Furnish all earth material for the construction of the shoulders. Provide earth material that meets the approval of the Engineer.

Measurement and Payment

Shoulder Construction will be measured and paid as the actual number of shoulder miles that have been constructed. Measurement will be made along the surface of each shoulder and to the nearest 0.01 of a mile.

Shoulder Borrow will be measured in its original position or in the haul truck and will be paid at the contract unit price per cubic yard.

Seeding and Mulching will be measured and paid as provided elsewhere in this contract.
