Electronic Bidding through Bid Express® is acceptable. **Do NOT submit your bid for the project let by Division 10 to the NCDOT Statewide Project Letting Office.**

Electronic Bid Preparation with Manual Delivery is also acceptable. Bids that are submitted by Electronic Bid Preparation with Manual Delivery must also include the entire Contract Proposal hard copy, the hard copy printout of the electronic bid sheet, the hard copy printout of the electronic subcontractors sheet, and the hard copy printout of the signature page. All required signatures and seals must be included on the bid sheet that is contained within the official Contract Proposal.
