The North Carolina Department of Transportation is requesting bids for replacement/repair of bridge expansion joints, epoxy overlay, crack sealing, and foam injections at various bridge sites within the six counties of Division 12. The Contractor is to furnish labor, material, equipment, and traffic control.

**The availability date for this contract is the date of execution of the purchase order. This is a one-year contract, which will expire 364 calendar days following the date of availability. At the option of the Department, this contract may be extended for two (2) additional periods of (1) year each for a maximum period of three (3) years total.**
