Subject: Invitation to Bid on Purchase Order Contract DM00274.

Project Description: Grading, Paving, Drainage, and Signals.

The North Carolina Department of Transportation is requesting bids for grading, paving, drainage, and signals at the intersection of US-19/23/74A and NC-63 (New Leicester Highway) in Buncombe County.

The availability date for this project is January 30, 2019.

The completion date for this project is September 30, 2019.

Bids for this project must be submitted electronically using the on-line system Bid Express[®]. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
