Project Description: Replacement of Structures.

The North Carolina Department of Transportation is requesting bids for replacement of structures number 281 over Sprinkle Creek on SR-1349 (Sprinkle Creek Rd) and number 100 over Casey Bow Branch on SR-1116 (Rector Corner Rd) in Madison County.

The date of availability for this contract is **February 18, 2019**.

The completion date for this contract is **April 18, 2020**.

Bids for this project must be submitted electronically using the on-line system Bid Express®. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.
