The North Carolina Department of Transportation is requesting bids for the extension of SR-1631 (Crossroads Parkway) to SR-1549 (Calvin Edney Rd) in Madison County.

The completion date for this project is **April 30, 2021**.

Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
