Project Description: Soil Nail Repair of Existing Retaining Wall and Micropile Slope Stabilization

The North Carolina Department of Transportation is requesting bids for soil nail repair of existing retaining wall and micropile slope stabilization on NC-226 approximately 3.4 miles north of US-221 in McDowell County.

Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.
