Subject: Invitation to Bid on Purchase Order Contract DM00400.

County: McDowell

Project Description: Pavement Texturing on 5.21 Miles of US-221

The North Carolina Department of Transportation is requesting bids for pavement texturing on 5.21 miles of US-221 from NC-226 to US-70 in McDowell County to be let at 2:00 PM on Wednesday, April 5, 2023.

The availability date for this project is **May 15, 2023**.

The completion date for this project is **July 14, 2023**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
