**NOTICE TO PROSPECTIVE BIDDERS**

Subject: Invitation to Bid on Purchase Order Contract DM00465.

County: Buncombe

Project Description: Pedestrian Improvements and Curb Ramp Upgrades

The North Carolina Department of Transportation is requesting bids for pedestrian improvements and curb ramp upgrades at various locations along NC-191 (Brevard Rd) in Buncombe County to be let at 2:00 PM on Wednesday, June 4, 2025.

The availability date for this project is **July 14, 2025**.

The completion date for this project is **October 15, 2025**.

**Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.**

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
