Project Description: I-26 Light Towing and Recovery Program

The North Carolina Department of Transportation is requesting bids for I-26 light towing and recovery program on I-26, I-240, I-40, US-25, and NC-191 in Buncombe and Henderson Counties.

The availability date for this renewable contract is **August 15, 2019**.

The completion date for this renewable contract is **August 14, 2020**.

In order for all prospective bidders to have an extensive knowledge of the project, all prospective bidders shall attend a mandatory pre-bid conference on Tuesday June 11, 2019 at 9:00 AM at the Skyland Fire Department located at 9 Miller Road South, Asheville, NC 28776 as described in the proposal.

Sealed bids must be received in the NC Department of Transportation Division Office at 55 Orange Street, Asheville, NC 28801 by 2:00 p.m. on Wednesday June 19, 2019. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:
