Subject: Invitation to Bid on Emergency ID/IQ Contract Cut and Shove 12982

Project Description: Emergency Cut and Shove

The North Carolina Department of Transportation is requesting bids for Cut and Shove upon request along various interstate, primary, and secondary routes in McDowell County to be let at 4:00 PM on Thursday September 26, 2024.

The availability date for this project is **September 27, 2024**.

The completion date for this project is **September 26, 2025**.

Bids must be received in the via email to celoftis@ncdot.gov, arbrown4@ncdot.gov, gjohnson@ncdot.gov by 4:00 p.m. on Thursday September 26, 2024. Bids must be submitted on the official bid sheet included in the proposal.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting a bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.

Any firm that wishes to bid as a prime contractor shall be prequalified as a Bidder or PO Prime Contractor prior to submitting a bid. Information regarding prequalification can be found at:
