Project Description: Guardrail Installation on SR-3116 (Mills Gap Rd) From 0.44 Miles East of US-25A to 0.11 Miles South of SR-3365 (Brompton Rd) and on SR-3121 (Rose Hill Rd) from 0.31 Miles south of SR-3074 (Bee Ridge Rd) to 0.18 Miles north of SR-3119 (Merrills Cove Rd) in Buncombe County.

The North Carolina Department of Transportation is requesting bids guardrail installation on SR-3116 (Mills Gap Rd) from 0.44 miles east of US-25A to 0.11 miles south of SR-3365 (Brompton Rd) and on SR-3121 (Rose Hill Rd) from 0.31 miles south of SR-3074 (Bee Ridge Rd) to 0.18 miles north of SR-3119 (Merrills Cove Rd) in Buncombe County.

Bids for this project must be submitted electronically using the on-line system Bid Express®. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.
