Project Description: Replace Bridge #151 and Replace Bridge #066

The North Carolina Department of Transportation is requesting bids for replace bridge #151 over Spillcorn Creek on SR-1330 (Bakers Creek Rd) and replace bridge #066 over Walnut Creek on SR-1396 (Hunter Creek Rd) in Madison County to be let at 2:00 PM on Wednesday, December 21, 2023.

The availability date for this project is **January 30, 2023**.

The completion date for this project is **May 30, 2025**.

Bids for this project must be submitted electronically. Refer to the Instructions to Bidders in the proposal for more information.

Firms that wish to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified **prior to submitting your bid**. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified **prior to beginning work on the project**.
