- 1. Is printing the proposal double sided required? No but it is encouraged
- 2. Will the plant inspection be completed by Kent Kolbe? Yes the Vegetation Management Section will be reviewing the plant certifications
- 3. Are the trees to be removed marked? Not at the present, trees are in the interchange and mostly pine
- 4. Are specifications available online? Yes
- 5. When is the \$5 million insurance required? The insurance is required within 14 days of award and must be carried throughout the life of the contract.

- 6. When will the replacement trees be planted? Replacement trees and shrubs under the warranty planting will be noted during the monthly meeting then replaced during the dormant season.
- 7. Why are the licensing requirements waived? The General Contractors license is waived in accordance with the General Statues. The Landscaping license was waived in an effort to attract and mentor more landscaping companies; however, for pesticide application a pesticide license with ornamental and turf endorsement is required
