Bid evaluation and award will be accelerated.

Submittal times for bonds and insurance will be reduced.

### There is NO pre bid meeting associated with this proposal.

Bidders must be prequalified as Bidder or PO Prime Contractor at the time of letting in order to be considered responsible.
