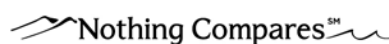

ADDENDUM 1 & PRE-BID MEETING NOTES

A Pre Bid meeting was held for the above referenced project on January 7, 2016 at 10:00 am at Bath Town Hall. Attached is a list of the attendees. The following was discussed;

- The General Project Special Provisions were reviewed.
- The Roadway Project Special Provisions were reviewed
- **Addendum** - In the section "Required References" (page 29) the sentence "The Contractor will provide all information requested on the reference sheet provided herein." Shall be deleted from this contract. The Contractor should provide their references in a letter format with the information needed to show proof of the ability to perform the work required in this contract.
- NCDOT will need to inspect and approve all plants at the nursery and receive a Department of Agriculture certification for the plants and an invoice.
- Labels and invoices from any Herbicide and Pesticides used on the project are required.
- Invoices for the Mulch when it is delivered to the project are required.
- A sample of the Top Soil, to be sent to the lab to check the PH levels, is required.
- Information regarding where the water is coming from, how much is used, and when it was received is required
- Invoices for any item used on the project is required
- **Addendum** - Additional information was provided regarding the Selective Vegetation Removal Sites. Site 1 is debris from trees that were limbed; the material will need to be hauled away since there is not enough room to chip and spread evenly in this area. Site 2 consists of 8-9 Crape Myrtles that will need to be removed. See the attached for a map and pictures of the sites.

- **Addendum** – A total of 14 trees (8 Lagerstroemia Natchaz Single Stem and 6 Ilex Nellie Stevens) are being removed from plan sheet 5 and the pay items. See the attached updated Itemized Pay Item sheet and submit this with your bid. Planting locations will be discussed in the field during the project.
- Certifications for the Work Zone Signs are required. This can be a letter provided by the contractor.

All addendum items are included as Addendum #1 for this contract.

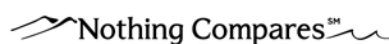

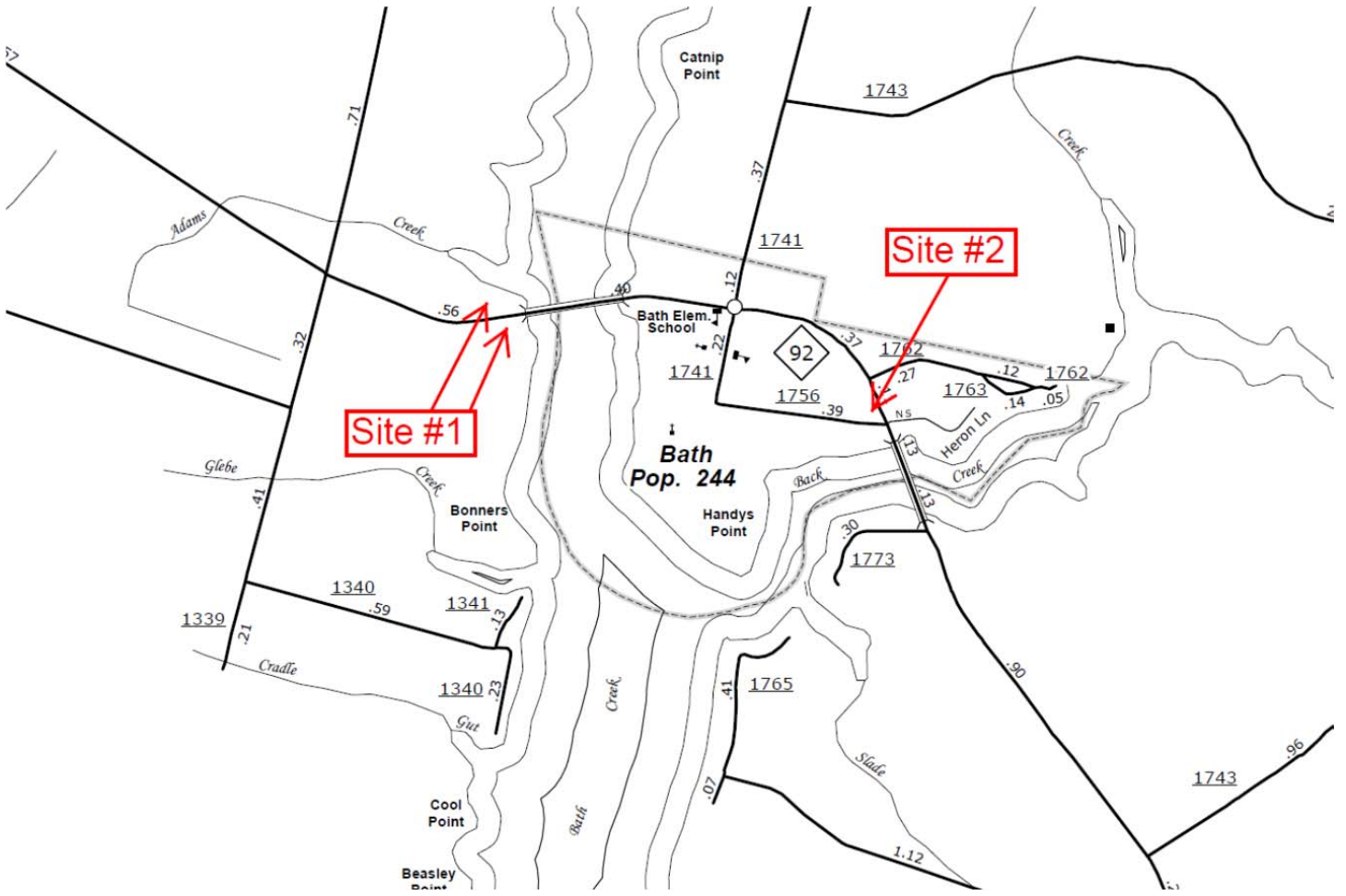
