## **Pre-Bid Meeting Notes**

A Pre Bid meeting was held for the above referenced project on May 13, 2016 at 11:00 am at the Craven County Maintenance Office.

Ms. Lentine began the meeting with reviewing the proposal. Items that were highlighted were;

- Notification of work from the NCDOT to the Contract will be by email only, with the exception of the Emergency Response.
- The camera used must be GPS enabled to show the location coordinates, time, and date.
- For the disposal of dead animals, the Contractor is responsible to know and follow the local laws and ordinances. The NCDOT will not provide any help in the disposal of the carcasses.
- Pictures of debris should show the approximate location and detailed enough to verify the count
- When called for trash bag pick up, the NCDOT will provide an estimated amount of bags to be picked up. If you arrive onsite and the number of bags is 10% or more over the estimated amount, you must call in to notify the NCDOT of the discrepancy before picking them up.
- If the number of items differ from amount picking up, for example if count was only for bags and there is a combination of bags and large debris, take separate pictures of the bags and debris and record both on the log sheet.
- The Contractor is responsible for the disposal of all trash, they should so their own research and know the costs associated with the local landfills, prior to submitting their bid.
- The importance of completely filling out the Execution of Bid, the Bid Form, and the Substitute Form W-9, was stressed.

There being no further business, the meeting was adjourned.
