The North Carolina Department of Transportation is requesting bids for the above referenced project. The contractor must furnish all labor, materials, equipment, and any other items necessary for the completion of this contract.

This is a Purchase Order Contract. Only those bidders which have been prequalified as a Bidder or a PO Prime Contractor may bid on this contract. The Contractor **MUST** have the NCDOT Work Codes 006000 (Disaster Debris Removal) and 006010 (Cut and Shove) to be considered for award. Failure to do so shall cause the bid to be deemed irregular and will not be processed.
