The North Carolina Department of Transportation is requesting bids for the bridge preservation consisting of pile jacketing of Bridge #139 on SR 1470 over Neuse River Overflow in Craven County. The contractor must furnish all labor, materials, equipment, and any other items necessary for the completion of this contract.
