The North Carolina Department of Transportation is requesting bids for the **State Funded Removal of Existing Pipe Culverts and Replacement with Aluminum Pipe Culverts and Headwalls in Onslow and Pender Counties**. The contractor must furnish all labor, materials, personnel and equipment.

Bids must be submitted on the official bid form included in the contract proposal and shall display the following statement on the front of the bid envelope:

The availability date for this project is April 4, 2016. The construction completion date is September 2, 2016. This project is subject to the Permanent Vegetation Establishment special provision, which holds the contractor responsible for 80% permanent vegetative coverage within 180 days following the structure completion, no later than March 9, 2017.


