The availability date for this project is **March 30, 2015**. The construction completion date is **July 31, 2015**. This project is subject to the Permanent Vegetation Establishment special provision, which holds the contractor responsible for 80% permanent vegetative coverage within 180 days following the structure completion, no later than January 26, 2016.

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the [Directory of Transportation Firms](#) as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let
