Subject: Invitation to Bid

The North Carolina Department of Transportation is requesting bids for Plant bed installation with irrigation including 'Welcome to North Topsail Beach' signs at two sites to include N.C. Highway 210 and Island Drive, also Scotch Bonnet Drive ocean side.

The availability date for this project is March 16, 2015. The completion date is April 24, 2015.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, and North Carolina 28429 by 2:00 PM on Thursday, February 19, 2015. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the Directory of Transportation Firms as either a Bidder or PO Prime Contractor. After this date, firms that prequalified as subcontractors only cannot bid on Division Let projects. 
