The North Carolina Department of Transportation is requesting bids for the **State Funded Replacement of Sampson County Bridges #316 and #317**. The contractor must furnish all labor, materials, traffic control, personnel and equipment.

The Department of Transportation does not exclude any person from participation in, deny any person the benefits of, or otherwise discriminate against anyone in connection with the award and performance of any contract covered by this program on the basis of race, color, sex, political affiliation/ influence, or national origin.

**BID OPENING**

Sealed bids must be received at the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 on Thursday, March 19, 2015 by 2:00 pm. Bids must be submitted on the official bid form included in the contract proposal and shall display the following statement on the front of the bid envelope:

The availability date for this project is **April 20, 2015**. The construction completion date is **October 23, 2015**. This project is subject to the Permanent Vegetation Establishment special provision, which holds the contractor responsible for 80% permanent vegetative coverage within 180 days following the structure completion, no later than April 20, 2016.


