The North Carolina Department of Transportation is requesting bids to Mat and Resurface and Widen for Paved Shoulders in Pender County. The project will include approximately 950 tons of B 25.0 B Asphalt, 3,140 Tons of S 9.5 B Asphalt & 205 Permanent Raised Pavement Markers. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is May 1, 2012. The completion date is June 8, 2012.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday April 19, 2012. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

QUOTATION FOR WBS ELEMENT # 3CR.20711.132: MAT AND RESURFACE AND WIDEN FOR PAVED SHOULDERS. TO BE OPENED AT 2:00 PM ON THURSDAY, APRIL 19, 2012.

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a

subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.
