The North Carolina Department of Transportation is requesting bids to Rehab Existing Storm Sewer by Installing CIPP Liners in Onslow County. The project will include 61'15" Pipe Liner, 30' 24" Pipe Liner, 220'30" Pipe Liner (2 locations), and 73' 48" Pipe Liner. It will also include Pipe Cleanout & Camera. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

A Mandatory Pre bid Conference will be held for this contract on Tuesday, April 7, 2015 at 10:00AM in the conference room at the District Engineers Office in Jacksonville, N.C.

**The availability date for this project is May 18, 2015. The completion date is September 11, 2015.**

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday April 23, 2015. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

Beginning **July 1, 2009**, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime

contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.


