The North Carolina Department of Transportation is requesting bids for the: **REMOVAL, REPLACEMENT AND INSTALLATION OF NEW MEDIAN CROSSOVERS ON I-40, I-140, US 74/76 in DIVISION 3**. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.


