The North Carolina Department of Transportation is requesting bids for Construction of Various Concrete Items in Onslow and Pender County. The project will include approximately 2200 LF of Concrete Curb and Gutter, 700 SY of Monolithic Island, 200 SY of 6" Concrete Slab . All of the quantities shown here are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is July 20, 2015. The completion date is June 30, 2016.


