The North Carolina Department of Transportation is requesting bids for the **State Funded Replacement of Onslow County Bridge #26.** All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

BID OPENING

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, July 17, 2014. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

QUOTATION FOR WBS ELEMENT # 17BP.3.R.1: State Funded Replacement of Onslow County Bridge #26 To Be Opened At 2:00 PM On THURSDAY, JULY 17, 2014.

The availability date for this project is **August 25, 2014.** The construction completion date is **August 21, 2015.** This project is subject to the Permanent Vegetation Establishment special provision, which holds the contractor responsible for 80% permanent vegetative coverage within 180 days following the structure completion, no later than February 17, 2016.

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the <u>Directory of Transportation Firms</u> as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects. The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all

bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

Statements of Minority and Women Business Enterprises participation must be presented with the bids. MBE goals are 3.0%, and WBE goals are 2.0% for this contract.
