This Mandatory Pre-Bid Meeting will begin promptly at 2:30 P.M. **Prospective bidders arriving after the 2:30 starting time will not be allowed to bid.** This Conference will be conducted by Department personnel for the purpose of providing additional informational about the project and to give all bidders an opportunity to ask any questions. Only bids received from the Bidders who have attended and properly registered at the Pre-Bid Conference will be considered. No questions concerning the project will be answered by the Department personnel at any time except at the Pre-Bid Conference.

Attendance at the Pre-Bid Conference will not meet the requirements of proper registration unless the individual attending has registered at the Conference with the following;

- 1) The individual signs his/her name on the official roster;**
- 2) The individual writes in the name and address of the company he/she represents;**
- 3) Only one company is shown as being represented by the individual attending.**
