Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

The availability date for this project is August 28, 2017. The completion date is June 29, 2018.

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the Directory of Transportation Firms as either a Bidder or PO Prime Contractor, After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects.
