## **NOTICE TO PROSPECTIVE BIDDERS**

### **Subject: Invitation to Bid**

- ***Project Description:*** Resurface Two (2) Secondary Roads in Sampson County.
- ***WBS Element #:*** 3C.082056 & 3C.082061

The North Carolina Department of Transportation is requesting bids for Resurface Two (2) Secondary Roads in Sampson County. The project will include approximately 8614 tons of S9.5A Asphalt, 231261LF of 4" Paint and 484EA Permanent Raised Markers. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is September 10, 2012. The completion date is December 15, 2012.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, August 16, 2012. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

QUOTATION FOR WBS ELEMENT # 3C.082056 & 3C.082061 : Resurface Two (2) Secondary Roads in Sampson County. TO BE OPENED AT 2:00 PM ON Thursday, August 16, 2012.

Beginning July 1, 2009, any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified prior to submitting a bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project.

For the purposes of prequalification, any firm that is currently prequalified as a prime or a subcontractor on central let projects for the appropriate work codes is considered eligible to work

and/or bid on Purchase Order Contracts as long as other items such as bonding and license requirements for the contract are met.
