The North Carolina Department of Transportation is requesting bids for the: **Clearing, Grubbing, Grading, Drainage, Widening, Resurfacing, Guardrail, Erosion Control, Pavement Markings, and Pavement Markers on SR 1411 in New Hanover County.** All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.


