The North Carolina Department of Transportation is requesting bids for the **State Funded Replacement of Brunswick County Bridge #53**. The contractor must furnish all labor, materials, personnel and equipment.

The Department of Transportation does not exclude any person from participation in, deny any person the benefits of, or otherwise discriminate against anyone in connection with the award and performance of any contract covered by this program on the basis of race, color, sex, political affiliation/ influence, or national origin.

BID OPENING

Sealed bids must be received at the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 on Thursday, October 23, 2014 by 2:00 pm. Bids must be submitted on the official bid form included in the contract proposal and shall display the following statement on the front of the bid envelope:

The availability date for this project is **December 1, 2014**. The construction completion date is **March 31, 2015**. This project is subject to the Permanent Vegetation Establishment special provision, which holds the contractor responsible for 80% permanent vegetative coverage within 180 days following the structure completion, no later than September 25, 2015.

Effective July 1, 2014, Division Let contracts should only be awarded to firms listed in the [Directory of Transportation Firms](#) as either a Bidder or PO Prime Contractor. After this date, firms that are prequalified as subcontractors only cannot bid on Division Let projects. Statements of Minority and Women Owned Business Enterprise participation must be presented with the bids. MBE goals are 3.0% and WBE goals are 2.0% for this contract.


