The North Carolina Department of Transportation is requesting bids for Surfacing, Resurfacing, Leveling and Widening on Various Roads Upon Request in Onslow County. All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is January 2, 2016. The completion date is December 31, 2016.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, November 5, 2015. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:


