





(STAKE TREES 8' OR TALLER)

HEALTHY VASCULAR ROOT SYSTEM (NO ROOT SHAVING - TREE COLLAR NEEDED) ONCE ROOT BALL IS PLACED IN THE HOLE, FOLD BACK (OR REMOVE) TOP $\frac{1}{3}$ OF FABRIC AND METAL CAGE. ROOT BALL SHAVING CAN SHAVE OUTER PERIPHERY OF ROOT BALL BE PERFORMED JUST PRIOR TO (MAX. 2") WITH SHARP SPADE SHOVEL PLANTING OR AFTER PLACING (OR HAND SAW) TO REMOVE GIRDLING IN THE HOLE. ROOTS.


> TREE PLANTING INSTRUCTIONS (FOR CONTAINER OR BALLED & BURLAPPED TREES)

PRUNE DAMAGED BRANCHES -INSTALL TREE OR SHRUB SO THAT 1/8 OF ROOT BALL IS ABOVE GRADE WATER RETENTION — RING FINISH GRADE — - MULCH COMPACT NATIVE SOIL BACKFILL


TREE OR SHRUB PLANTING DETAIL (SLOPING GROUND)

NOTES:


- PLANT HOLE WIDTH TO BE TWICE THE ROOT BALL SIZE OR CONTAINER DIAMETER.
- APPLY HERBICIDES A MIN. OF 7 DAYS PRIOR TO PLANTING, BY LABEL INSTRUCTIONS, OR AS DIRECTED BY THE NCDOT ENGINEER.
- APPLY FERTILIZER AT PLANTING TIME IN THE FORM OF A SLOW RELEASE PELLET OR TABLET. APPLY AT RATE RECOMMENDED BY MANUFACTURER. BOTH RATE AND FORMULATION MUST BE APPROVED BY FIELD ENGINEER PRIOR TO APPLICATION.
- ALL PRUNING TO FOLLOW STANDARD ARBORICULTURAL PRACTICES AS SPECIFIED BY INTERNATIONAL SOCIETY OF ARBORICULTURE.
- DO NOT ATTEMPT TO STRAIGHTEN A TREE THAT HAS BEEN PLANTED AT AN ANGLE WITH THE USE OF STAKING OR GUYING. DIG TREE AND REPLANT TO UPRIGHT POSITION.




CLASS "A" STONE DITCH LINING DETAIL




SHRUB BED PLANTING DETAIL




GUARDRAIL MULCHING DETAIL USE AS DIRECTED BY FIELD ENGINEER
